CAT OWNERS RESPONSIBILITIES

The *Cat Act 2011* states cat owners must ensure:

- Cats aged six months and over must be registered
- Proof of cat being sterilised and microchipped (eg: sterilisation and microchip certificates)
- Inform the City immediately of any changes in ownership, the death of a cat or any change of address
- Cat registrations must be renewed prior to 1 November. Penalties may apply for failing to renew your cat registration.
