For installation of Paving or other hardstand and/or Synthetic Turf

An Application is NOT required for installation of lawn, reticulation, organic mulch or a verge garden, provided they meet the City's Street Verge Landscape Guidelines.

NOTE: Verges should not consist of more than 50% of hardstand area. This includes driveway crossovers + footpaths + all hardstand materials including concrete, asphalt, paving, and synthetic turf. The exception is for verges of less than 1.5 metres wide, not including the width of the footpath; where it is not practicable to maintain a natural lawn or garden.
