## Home Safety and Security Equipment Rebate Program

## **Terms and Conditions**

- 1. Applications can be submitted for residential properties only located in the City of South Perth.
- 2. The City of South Perth has the sole discretion to assess applications. Eligible applicants may receive a maximum of one rebate only within the financial year.
- 3. Eligible items include: CCTV, home alarms, gate alarms, deadlocks for doors and windows, window guards, roller shutters, security doors/screens, sensor lights, Wi-Fi video doorbell, meter box locks, letter box locks etc.
- 4. This rebate program only covers equipment. Non-equipment purchases (such as fences) and yearly subscription services are not eligible for a rebate.
- 5. Applicants can purchase/install higher specification home safety equipment; however, the rebate amounts as specified will remain regardless of the final project cost.
- 6. The applicant agrees that the City is not responsible for any claims arising from any loss or damage to any person or their property as a result of the rebate program. The applicant indemnifies the City from any claims arising from any loss or damage to any person or their property as a result of the rebate program.
- 7. The City may choose to promote this rebate program in any of its publications or through its media platforms.
- 8. The City encourages applicants to use local businesses when purchasing home safety and security equipment where possible, as per the City's "Buy Local, Shop Local" Campaign <a href="https://southperth.wa.gov.au/development/services/business-directory">https://southperth.wa.gov.au/development/services/business-directory</a>
- 9. There is no guarantee that a rebate will be provided to all applicants if the allocated budget is fully expended prior to the end of the financial year.
- 10. Applications received in late June may be processed the following financial year.



- 11. Applicants must be a local property owner or act on their behalf with signed consent.
- 12. Applicants must complete the feedback form to be considered for a rebate.
- 13. All funds are transferred electronically. Nominated bank account for rebate program must be in the applicant's name; and payments cannot be made to business accounts, charities, or trust accounts.
- 14. Applicants must have a valid concession card if applying for the higher rebate category.
- 15. The rebate program is intended to assist with new safety/security equipment only. Receipts for security equipment must be dated within the current financial year to be eligible.
- 16. Applicants must be 18 years or older.
- 17. Applicants who install CCTV are encouraged to join the WA Police Force Cam-Map WA database. <a href="https://www.police.wa.gov.au/Your-Safety/State-CCTV-Register">https://www.police.wa.gov.au/Your-Safety/State-CCTV-Register</a>
