

# Home Safety and Security Equipment Rebate Program

## Terms and Conditions

1. Applications can be submitted for residential properties located in the City of South Perth only.
2. The City of South Perth has the sole discretion to assess applications. Eligible applicants may receive a maximum of one rebate only within the financial year.
3. Eligible items include (but are not limited to): CCTV, home alarms, gate alarms, deadlocks for doors and windows, window guards, roller shutters, security doors/screens, sensor lights, Wi-Fi video doorbell, meter box locks, letter box locks etc.
4. This rebate program covers new safety/security equipment only. Fire extinguishers, fire alarms and non-equipment purchases such as fences and yearly subscription services are not eligible for a rebate.
5. Applicants can purchase/install higher specification home safety equipment; however, the rebate amounts as specified will remain regardless of the final project cost.
6. The applicant agrees that the City is not responsible for any claims arising from any loss or damage to any person or their property as a result of the rebate program. The applicant indemnifies the City from any claims arising from any loss or damage to any person or their property as a result of the rebate program.
7. The City may choose to promote this rebate program in any of its publications or through its media platforms.
8. There is no guarantee that a rebate will be provided to all applicants if the allocated budget is fully expended prior to the end of the financial year.
9. Applications received in late June may be processed in the following financial year.
10. Receipts for security equipment must be dated within the current financial year to qualify. Receipts older than one year will not be considered.

11. Applicants must be a local property owner or act on their behalf with signed consent.
12. Applicants must complete the feedback form to be considered for a rebate.
13. All funds are transferred electronically. Nominated bank account for rebate program must be in the applicant's name; and payments cannot be made to business accounts, charities, or trust accounts. Applicants must provide a copy of the top of their current bank statements, and it must be dated within the last six months to be eligible.
14. Applicants must have a valid concession card if applying for the higher rebate category.
15. Applicants must be 18 years or older.
16. Applicants who install CCTV are encouraged to join the WA Police Force Cam-Map WA database. <https://www.police.wa.gov.au/Your-Safety/State-CCTV-Register>
