#### **HISTORICAL NOTES**

(Much of this historical material is drawn from a Wikipedia article – 'Blue Waters, Perth'. 1)

Despite this *Residence:* 426 Canning Highway - 'Blue Waters' being recognised by two eminent architectural authorities as 1930s design style, the house was actually approved by the South Perth Council in 1951. It has been described as having functionalist, Art Deco and International Cubist characteristics. The house was built in 1952-53 by Mabel and Keith Perron.

Shortly before World War II, the Perrons were inspired by a magazine illustration of a Florida Art Deco house design. Work towards construction of the 1930s design was delayed, owing to the shortage of building materials during and after the War. The house plans were approved by South Perth Council in 1951, but construction did not occur until a year or two later. Due to the design of 'Blue Waters' involving a greater quantity of bricks and glass than the ration system permitted, Keith Perron decided to establish a brickworks from which to source the required quantity of bricks. <sup>1</sup> The curved glass windows and frames could not be manufactured locally and were shipped from the U.K.

The house became both a social hub and a landmark for many years, outside which tour buses would regularly pause.

Blue Waters made an ideal location for photographic backdrops for the modelling career of the Perron's daughter, Judith.

Keith Perron's cousin, Marshall Perron, lived at Blue Waters for a while as a young man before becoming a Northern Territory politician. He was a Country Liberal Party member of the Legislative Assembly in the Northern Territory from the formation of the Assembly in 1974 until his resignation in 1995. From 1988 to 1995, Perron was the Chief Minister of the Northern Territory.<sup>2</sup>

In May 1956, Council approval was given for the erection of a garage adjoining the rear of the house, abutting the southern boundary of the site. Access to this garage would have been via the rear right-of-way, Daisy Lane. This building was later converted into a games room.

## **HISTORICAL NOTES (cont'd)**

In 1961, the *Residence: 426 Canning Highway - 'Blue Waters'*, complete with its original furniture, was sold to Joy and Eric Lillingston, owner of the yacht 'Yeulba', for £12,500 (A\$25,000). In 1965, it was bought by Mr Bodica, a bookmaker, and in 1973 by the deputy mayor of Fremantle and butcher, Denis Sowden and his wife Margaret. In 1974, the property was sold to Mirjam Norvilas who retained the house for 32 years before selling in 2006 to David Cavanagh, who has restored the house to its original condition.

In May 2013, the *Residence: 426 Canning Highway - 'Blue Waters'* was one of the venues for the filming of the movie, *The Reckoning*, written by John V Soto and starring Luke Hemsworth and Jonathan LaPaglia. The property owner, David Cavanagh was the film's associate producer.

Although set back about 17 metres from the street boundary, the *Residence:* 426 Canning Highway 'Blue Waters' is in threat of possible damage or demolition due to Canning Highway road widening works that are proposed by the State government. In July 2013, at the request of David Cavanaugh, owner, the Council resolved that:

- "(a) in order to conserve and protect the integrity of the heritage-listed house, 'Blue Waters', on Lot 206 (No. 426) Canning Highway, Como, the Council supports a reduction in the width of the proposed road widening across the site from 17.5 metres to 16.0 metres;
- (b) the WA Department of Transport be requested to reduce the planned road widening for this lot, as referred to in part (a) above;
- (c) if the Department of Transport agrees to reduce the road widening from 17.5 metres to 16.0 metres in this location, the Department of Planning be requested to implement a corresponding amendment to the Metropolitan Region Scheme."

The Council request was referred to the relevant government agencies, but at the time of preparing these notes, the effect of this long-term project on the *Residence: 426 Canning Highway - 'Blue Waters'* has not been finally resolved. It will be reviewed by Main Roads Western Australia closer to implementation of the Canning Highway upgrade project.

#### DESCRIPTION

The Residence: 426 Canning Highway - 'Blue Waters' is situated on Canning Highway set back some distance from the road. It has a dominant curved (almost circular) two storey section with a one storey wing. The single garage is situated under the house. The mature palm trees that are the main feature of the landscaping in the front yard appear to fit with the almost nautical feel of the house.

This *Residence:* 426 Canning Highway - 'Blue Waters' has many features that place it in the Functionalist/Art Deco design style category. These include asymmetrical massing, simple geometric shapes, long horizontal balcony (similarities to a ship), roof concealed behind parapet, rounded corner and windows with curved glass and aluminium frames.

The house, though built in 1952-53, has the classic lines of a style of architecture first introduced in the 1920s and 1930s, which emphasised functionalism, clean lines and a complete disassociation from the past.

<sup>&</sup>lt;sup>3</sup> Yeulba was built in Auckland in the 1920s for Lord Forster, Governor-General of Australia. The 8 metre yacht was made from New Zealand kauri timber, and was designed by W Fife, well-known Scottish boat designer. #### STATEMENT OF SIGNIFICANCE

The *Residence:* 426 Canning Highway - 'Blue Waters' has aesthetic, representative and rarity cultural heritage significance. It has been recognised by a number of heritage and architectural professionals for its unusual design style. It has high streetscape value and is a fine representative of functionalist architecture. Residences of this design style with such high integrity and few changes to the original external plan are rare in the City of South Perth.

#### MANAGEMENT RECOMMENDATIONS

## Management Category B: Considerable significance

Conservation essential. Reflects the highest level of local cultural heritage significance. Very important to the heritage of the locality. High degree of integrity and authenticity. Demolition or significant alteration to a place in Management Category B of the Heritage List is not permitted. Any alterations or additions are to be guided by a Conservation Plan, if any, and reinforce the heritage values of the place.
