- Located 4km south of the Perth CBD
- Established as a Roads Board in 1892
- Proclaimed in July 1959 as a City
- Proposed amalgamation with Town of Victoria Park rejected by community vote 2015
- Comprises suburbs of Como, Karawara, Kensington, Manning, Salter Point, South Perth and Waterford
- Major attractions: Mindeerup, South Perth Foreshore/ Sir James Mitchell Park, Perth Zoo, Collier Park Golf Course and Mini Golf, the Old Mill, Ferry Tram.



The Council


The City of South Perth is a Band 2 local government and is divided into four wards each represented by two Councillors – eight in total:

Mill Point x 2 Como x 2 Moresby x 2 Manning x 2

The Council is presided over by a popularly elected Mayor.

All nine Elected Members hold four-year terms.

Council elections are held every two years on the third Saturday in October for half of the Councillors – 1 in each ward.





Governance and Ethical Standards

Council

The role of the Council, as prescribed by the Act, is that it:

- governs the local government's affairs
- is responsible for the performance of the local government's functions
- allocates the local government's finances and resources to the services and facilities that it decides are to be provided
- strategically plans for the future and provides strategic direction to the CEO, including managing the CEO's performance
- determines the local government's policies
- must have regard to the need to support an organisational culture for the local government that promotes the respectful and fair treatment of the local government's employees



Governance and Ethical Standards

Elected Members

The role of each councillor, as prescribed by the Act, is to:

- represent the interests of electors, ratepayers and residents and considers the interests of those who work or visit the
 district
- provide leadership and guidance to the community
- facilitate communication between the community and the council
- facilitate and maintain good working relationships with other councillors, the mayor or president and the CEO
- act consistently with the principles around respecting the separation of roles, making good decisions and supporting a
 positive organisational culture
- participate in decision making processes at meetings
- perform such other functions as are given to a councillor by the Act or any other written law.



Things to be aware of during your election campaign:

Councillor Code of Conduct

The Councillor Code of Conduct sets the standards for the behaviour and conduct for Elected Members, Committee Members and Candidates. If you breach the Councillor Code of Conduct during your election campaign and are elected a complaint may be bought against you.

Signage

Election signage cannot be placed on or in buildings or property owned or managed by the City. This also applies to promotional materials being handed out at buildings and at City run events (including but not limited to posters, flyers and all other advertising material.

Social Media

Social Media usage must comply with the Councillor Code of Conduct and must only publish material that is factually correct.


