# Opening of Public Question Time

# 5.1 Mr Robert Simper, Sandgate Street, South Perth

#### Summary of Question

The front page of the Southern Gazette newspaper, April 3 - 9 states that members of the public are welcome to attend this Special Council Meeting but that the discussion about the Chief Executive Officer would be behind closed doors whereas the advertisement on page 19 states the meeting is not open to the public. Who is responsible for the advertisement, was it the CEO?

#### Summary of Response

#### Summary of Question

Is the Notice put out by the Chief Executive Officer that the meeting is not open to the public legal?

There have been a number of press statements and comments in the newspaper recently. Is tonight's meeting regarding the CEO?

#### Summary of Response

#### Summary of Question

Regarding the confidential item and the press release 29 March the Mayor states *not* appropriate for me to comment etc and to a further comment have personal confidence in CEO.....etc Was the confidential item regarding the CEO?

#### Summary of Response

The Mayor stated this was a similar comment as that given to the West Australian newspaper.

### Summary of Question

The Local Government Act states that the Mayor speaks for Council. If the confidential item relates to confidence in the CEO is this press release in conflict with what Council resolved?

#### Summary of Response

The Mayor stated that he had been speaking personally and that he was not going to debate the issue.

#### Summary of Question

The President of the LGMA mentioned the CEO is honest etc is there any implication he is not?

#### Summary of Response

The Mayor suggested Mr Defrenne ask Mr Lumsden.
