## September 2013 – Council Agenda Reports

#### 10.0.1 Proposed Amendment No. 35 to Town Planning Scheme No. 6: Home Occupation and Home Office definition and requirements – Consideration of submissions and final adoption

This report seeks Council consideration of public submissions and agreement that Amendment 35 be finally adopted by the Council with modifications and forwarded to the Western Australian Planning Commission for final approval by the Minister for Planning.

Amendment No. 35 specifies additional restrictions applicable to Home Occupations and Home Offices and modifies the existing definitions of those land uses. (For example: permissible tare weights of vehicles, permissible number of client visits, on-site client parking bays and food-based Home Occupations).

# 10.1.1 Community Sport and Recreation Facility Fund (CSRFF) – Annual/Forward Planning Grants

#### Opening

The Mayor opened the Briefing at 5.30pm and welcomed everyone in attendance, noting that the last Joint Council Members' Briefing had been held on 30 October 2012.

#### Introduction

Steve Cope, Director Strategic Urban Planning at the City of Melville spoke about progress since the last Joint Briefing. He said that, with the intention to promote more intensive development within the Canning Bridge Precinct, it is critically important to effectively manage movement by way of various modes of transport. Being mindful of this, a considerable amount of time has been spent in conducting and refining traffic modelling and forecasting the level of patronage of public transport to a point where the consultants and Project Working Group members are satisfied that the total transport network is capable of meeting demand. Steve explained that a significant part of the delay with the project is attributable to this traffic modelling.

#### **Topics Discussed**

Consultant, Anna Kelderman from GHD delivered a PowerPoint presentation covering the following:

#### Study Progress

- Phase I (Analysis) has been completed.
- Phase 2 (Concept Plan) refining the 'Vision'. This phase is nearing completion.
- Phase 3 (Activity Centre Structure Plan). This phase will commence following input at the next community workshop.

#### Community Engagement to Date

- Community Briefing Session
- Two Community Workshops
- Community Survey at Applecross IGA and Canning Bridge Train Station
- Youth Workshop with South Perth Youth Network and Melville Youth Advisory Council.

#### **Completed Studies**

- Transport: Iterative process to refine the modelling. Also has taken into account the Draft Integrated Transport Strategy and response from community consultation.
- Environmental Assessment: Explored opportunities for improving habitat and water quality. Also local water management not overloading regional systems.



- Retail and Economics: Iterative process exploring how to capitalise on unique land use characteristics of the Precinct. Retail Needs Assessment focussing on economic diversity and sustainability.
- Service Infrastructure: Iterative process exploring ways to reduce reliance on regional infrastructure and devising a Sustainable Infrastructure Strategy.
- Built Form Study: Iterative process taking into account responses to the Vision, refinement into a concept plan and further refinement into response from community input.

#### Concept Plan – Moving Forward

- Continues to be based on the six 'Quarters' (Applecross, Mt Pleasant, Transit, Como Beach, Como/Manning and Manning South).
- Concept Plan now reaching an advanced stage of refinement.
- For effective communication, proposals will be communicated by way of three 'posters' based on the three main themes, being: Built Form, Movement and Public Spaces.
- Some road intersection issues still being investigated e.g. Canning Highway / Kintail Road and Canning Highway / Sleat Road.

#### **Council Members' Questions / Issues**

Members raised the following questions and issues of clarification:

- To further enhance community information about the project, copies of the 'posters' should be placed on display in prominent locations within the Precinct.
- Concern about high traffic congestion and queuing in Sleat Road during peak hours.
- Solutions need to be found to improve pedestrian access to the train station and across Canning Bridge.
- The Structure Plan needs to be flexible enough to accommodate alternative transport solutions which may prove feasible in the future e.g. light rail continuing westwards beyond Canning Bridge.
- Query as to why it is forecast that locally generated traffic will not significantly increase. <u>Response</u>: Changing mix of dwelling types and initiatives to attract residents and workers to public transport rather than passenger cars.
- Query regarding estimated timing of construction of the new bus station and the Cassey Street bus bridge. <u>Response</u>: At this stage, it is not possible to estimate the timing – will depend on progress of development. The Cassey Street bus bridge is only an option and may or may not be built.
- Disagreement with the concept of development bonuses in return for provision of community facilities. <u>Response</u>: There will be quite demanding mandatory design guidelines for all development. In addition, further development bonuses may be allowed in return for provision of appropriate additional community facilities or infrastructure.
- We need to take the community 'along the journey', having regard to the lengthy time span of the project and the high turnover of resident population in the precinct. <u>Response</u>: This is agreed and will be discussed further at forthcoming Project Working Group meetings. Reference was made to the 'Journey So Far' which has previously been circulated. Updated information is being placed on both Councils' websites. Further initiatives in this regard will be investigated.



• How often do the Steering Groups meet?

<u>Response</u>: The Project Working Group has been meeting on a monthly basis. Two meetings of the Reference Group have been held (Mayors, CEOs and Directors-General).

#### Actions/Outcome

Steve Cope advised that the posters will be further modified and refined prior to circulation to Council Members.

When the posters have been finalised, they will be presented to the next community workshop for input by the attendees. The workshop date has not yet been set but it may be held late in October 2013.

Councillors were advised that the Joint Taskforce would continue working on the draft Submission Paper with it proposed to be released for public information via the City's website, week ending 27 September 2013. It is proposed that the City and the Town of Victoria Park would schedule respective Special Council Meetings the week ending 4 October 2013 to consider the final Submission Paper.

#### Item 5.4 Building Act 2011 – Fees, charges and administrative requirements

#### **Officer Comment**

- The Building Act 2011 has been implemented for one full financial year and examples of the new Act on the income and operation of Local Government building departments has been obtained.
- Generally there has been between a 30 40% drop in revenue at a number of Local Governments, with this reduction in revenue now being met by general revenue to support the operation of the building department.
- The new Act has resulted in an increase in administrative requirements and when combined with the tight timelines for issuing building permits, there is significant pressure on officers and on the performance of building departments.

#### Officer Recommendation

That the recommendation be supported.

#### **Zone Resolution**

The Zone endorsed the recommendation.

However, Delegates from the City of Armadale suggested some changes to the agenda item:

- WALGA consulted Local Governments and feedback provided shows a high level of satisfaction with the current arrangements.

# Item 5.7 Heavy Vehicle Charging and Investment Reform – Options Development Submission

#### WALGA Recommendation

That the Association's interim submission to the 'options development' stage of the Heavy Vehicle Charging Investment Reform (HVCI) Project be endorsed.

#### **Officer Comment**

- The current heavy vehicle pricing regime (registration charges and fuel excise) is considered to result in inefficient outcomes. The HVCI reforms aim to deliver greater productivity within freight transport through improved access for heavy vehicles and more efficient investments in the road network
- The HVCI project is now developing an integrated charging, funding and investment framework and is also working on implementation strategies for the proposed reforms. This work is part of the Regulatory Impact Statement (RIS) which is expected to be released for public comment at the end of 2013.
- The current focus of the project's consultation activities is supply side reforms. These focus on the ways in which road providers, including road agencies such as Main Roads WA and Local Governments, are funded and operate in delivering road services. In June 2013, HVCI released an 'Options Development Discussion Paper' to seek feedback on the supply side reform process. The Association's made an interim submission in response to this discussion paper (please see attachment).
- As the major provider of road infrastructure, Local Government should take an active role in identifying the impacts of proposed regulatory reform and ensuring proposed changes lead to sustainable funding and delivery arrangements for local roads used by heavy vehicles.

#### **Officer Recommendation**

That the recommendation be supported.

#### **Zone Resolution**

The Zone endorsed the recommendation.

#### **State Council Resolution**

That the Association's interim submission to the 'options development' stage of the Heavy Vehicle Charging Investment Reform (HVCI) Project be endorsed subject to Local Government retaining the ability to levy and collect charges as well as negotiate with local road network users.



#### Item 5.8 Community Emergency Risk Assessment Tool

#### WALGA Recommendation

- In February 2013, the Department of Local Government released a Circular n° 05-2013. Local Government (Audit) Amendment Regulations 2013. The amendments require local Government to review, at least once every two years, the appropriateness and effectiveness of the Local Government's systems and procedures in regard to risk management, internal control and legislative compliance.
- WALGA Emergency Management Services has developed and trialled the Community Emergency Risk Assessment Tool (CERAT) to support Local Government risk management systems and procedures.
- The six month trial, supported by the State Emergency Management Committee (SEMC) demonstrated its effectiveness to meet risk management requirements prescribed through regulation. WALGA is keen to seek further funding from the SEMC to develop the CERAT for broader Local Government implementation.

#### **Officer Recommendation**

That the recommendation be supported.

#### Zone Resolution

The Zone endorsed the recommendation.

#### **State Council Resolution**

- 1. That the Community Emergency Risk Assessment Tool be endorsed for further development as the preferred emergency risk management tool for Local Government in Western Australia.

#### PRESIDENT'S REPORT September 2013

#### CONSTITUTIONAL RECOGNITION

The campaign for Constitutional recognition has been frustrated with the announcement of an early election date. The scheduling of the Federal Election on September 7<sup>th</sup> means it is not technically possible to hold a simultaneous referendum. It would appear that the future prospects for a referendum are now dependent on the election outcome, with the election of a Coalition Government likely to see the deferral any poll to the 2016 federal election at the earliest. The ALGA is currently negotiating with the Federal Government for retention of the \$10M funding provided for the "YES" campaign to defray the costs incurred by State Associations to date in promoting the referendum, on the basis that it was the government's decision to call the election early than anticipated that caused the abandonment of the referendum, not any failure on the part of local government.

#### LOCAL GOVERNMENT CONFERENCE

It is over for another year and going by the feedback we received, it was a great success. The speakers were very well received and it seems we're striking the right mix of workshops, forums and speakers. The Gala Dinner ended the Conference on a spectacular note with good food, great entertainment and excellent fellowship amongst the delegates. I would encourage you to give us your feedback in writing as soon as possible, so that we can incorporate your ideas in our planning for the future. A big thank you to delegates for your support and attendance – we look forward to making next year's Convention even better.

#### STATE BUDGET

The 2013-14 State Budget was released on 8 August and includes a range of spending cuts and tax increases deemed necessary to control the State Government's growing debt and adjust

taxation and expenditure settings to avoid more frequent deficits in the future. While the 2013 -14 budget is expected to result in a surplus of \$386 million, a deficit of \$147 million is expected in 2014-15.

It is extremely disappointing to see future funding for the Country Local Government Fund all but discontinued in the most recent State Budget. The 2013-14 budget only allocates \$34.5 million to the <u>Country Local Government Fund</u> which is substantially lower than the expenditure of \$76.4 million in 2012-13. The Government has advised that there will be alternative sources of funding available to regional Local Governments through different initiatives, however Local Governments in the regions will be impacted by these amendments to a dedicated infrastructure funding source. WALGA will be preparing a case to take to the State Government to demonstrate the ongoing value of a dedicated Country Local Government Fund and the need for such a fund to continue.

- There is confusion over the change in <u>Street Lighting tariffs</u> for local governments, with the Budget Papers indicating an 11.8% increase, despite comments from the Energy Minister assuring the media that the increase is only 1%. The Association is still awaiting formal clarification from the Minister.
- \$2 million will be spent in 2013-14 as initial support to metropolitan Local Governments in planning for the implementation of <u>Metropolitan Local Government</u> <u>Reform</u>. However, the budget papers provide no indication of the reform expenditure that will be required beyond 2013-14.
- An additional \$20 million has been allocated from 2014-15 to 2015-16 within the <u>Community Sporting and Recreation Facilities Fund</u> (CSRFF) for community groups and Local Government authorities to develop sport and recreation infrastructure
- The <u>Community Pool Revitalisation Program</u> begins in 2015-16 and is intended to
  provide an annual grant of up to \$30,000 to all regional Local Governments that have
  a public swimming pool. The funds are for maintenance and upgrading and the
  scheme is expected to cost \$3 million per year.

The increased funding for swimming pools and the CSRFF can be regarded as a very good outcome – WALGA has long advocated for increased funding towards fitness and recreation infrastructure for the State's communities.

#### ROAD WISE FUNDING REDUCTION

For almost 20 years WALGA has worked with Councils across the State to deliver the Road Wise program to promote community road safety. Disappointingly, at very short notice, we were recently advised that funding for the Road Wise program would be slashed by half and that the government expected WALGA – a non-government, not for profit, association – would pay for all future administration costs. This is an unrealistic and inappropriate expectation by the State Government and has been rejected in a counter-offer to run a reduced road safety program within the funding available based on WALGA's standard costing model. This has been accepted by the Minister and is being finalised by staff. Clearly the State Government's severe financial situation is going to be problematic, not only this year, but for future financial years also.

#### ONE70 UPDATE

I am pleased to report that construction is on schedule to be completed in December this year with the move early in the New Year. The building continues on to meet both its budget and construction targets and is set to become an icon building in the Leederville precinct. I encourage all of you to take the opportunity when in the vicinity to drive by and have a look at the amazing progress that is being made.

# DELEGATES' REPORT Perth Airport Municipalities Group Meeting [PAMG]

The Perth Airports Municipalities Group Meeting was held at the City of Gosnells on Thursday 5 September 2013 at 7.00 pm. The City of South Perth was represented by Councillor Ian Hasleby and the A/Chief Executive Officer Phil McQue.

The agenda (Copy of Table of Contents attached) contained a number of items, a summary of which follows:

#### 9. **NEW BUSINESS**

#### 9.1 Review of the Airports Building Control and Environmental Protection Regulations

The Group noted that a first stage discussion paper was issued by the Department of Infrastructure and Transport on I May 2013 seeking comment from interested parties on options to amend the Airports (Building Control) Regulations 1996 and the Airports (Environmental Protection) Regulations 1997.

#### 9.2 Urban Development Institute of Australia (National)

WALGA has forwarded for the PAMG's information and discussion, a media statement dated 25 July 2013 released by the Urban Development Institute Australia (National) (UDIA - based in Canberra) putting forward a series of key actions the Institute considers as election priorities for Housing Policy.

The point of interest relating to development around airports is:

#### Why is Government making housing so expensive? ACTION: Cut red tape by:

Stopping Commonwealth measures to restrict development around airports and airport corridors beyond the current and existing standards.

The Chair opened discussion and commented that a lot of time is spent in land use planning to ensure flight paths have minimum impact. The key points of the discussion were:

- For any new residential development in areas affected by aircraft noise as long as residents are fully aware of the noise levels then no reason to complain.
- Reference to Guildford residents and their properties being developed prior to the development of Perth Airport.
- Section 70 memorials on titles and noise mitigation strategies in use.
- The importance of State Planning Policy 5.1 (SPP5.1), its application, and issues raised by Perth Airport for a Shire of Kalamunda development even though compliant with the provisions of SPP5.1.
- Ongoing problems of developments near airports and airport/population expansions.

#### I0. GENERAL BUSINESS

#### 10.2 Noise

A general discussion was held on the role of the PAMG and Community Aviation Consultation Groups (CACG), the duplicity of agenda content and how other groups around the country are operating with specific reference to the Melbourne Airport CACG.

The PAMG were notified that the Department of Infrastructure and Transport has issued a survey to establish the effectiveness of CACGs. It was suggested that members should have input into that survey and put forward honest and forthright opinions.

#### Review of AS2021-2000

The Standards Development Committee of Standards Australia completed its initial assessment of the proposal to revise AS 2021-2000 as submitted by the Department of Infrastructure and Transport but determined that there was insufficient stakeholder support for the scope of the review. In February 2013 Standards Australia convened a stakeholder forum to discuss the revision. The review proposal was subsequently amended. It has been suggested that a culture change at Standards Australia may be needed to ensure the appropriate parties are consulted.

The Chair advised that WA is currently represented through ALGA and that Standards Australia has recently approved the development of a new document to describe aircraft noise subject to the determination of a clearly defined scope.

#### **10.3** Community Aviation Consultation Groups (CACGs)

The minutes of the Perth Airport CACG were tabled and Chair of the Jandakot Airport CACG provided an update on the Jandakot CACG's activities and challenges.

#### 10.4 Quarterly Airport Reports

#### 10.4.1 Perth Airport Report

The representative from Perth Airport provided the quarterly update on operations and developments at Perth Airport.

Key Points:

- Redevelopment in full swing, lots of advertising.
- Domestic pier to be finished next year.
- Arrivals lounge to open in 7 weeks.
- Qantas operating out of TI and T3 and confusing for passengers.
- Car park at T2 to open shortly.
- Gateway project preliminary works environmental approvals obtained, money is in the bank and clearing commenced.
- Slowing domestic passengers 0.7% down and possibly changing of mining industry.
- 3rd runway working with 24 airlines to try and get agreement on timing of works. Perth Airports Pty Ltd (PAPL) consider it is needed and earliest date for opening is 4 years from the date of agreement with the airlines.
- Pending cross runway closure for crucial maintenance 30 addition arrivals/departures. Direct mail out to residents and brochures to come to LG libraries etc.

• Master plan process mapped out final submission to Minister October 2014. Presentation to PAMG at next meeting on the Master Plan

#### The Australian Airport Association (AAA) National Conference

The Australian Airport Association (AAA) National Conference theme was 'Navigating the Future' and attracted more than 350 interstate and overseas delegates to the Darwin Conference Centre in September.

AAA represents the interests of more than 250 airports and aerodromes around Australia, linked to extensive economic activity, achieving increased passenger and freight activities, expansion of fly-in-fly-out operations in the resource sector and a steady balance in the inbound and outbound tourism market.

#### Stephen Goodwin, Chairman of AAA

Welcomed delegates and flagged the new Federal Government's acceptance of its Airport Industry Policy Priorities 2013/14, outlining the industry's position on specific regulatory and policy issues.

The document is intended to be a guide for all airport stakeholders including MPs, local, state and federal government departments, and industry supporters available at: **www.aviationbusiness.com.au**.

Mr. Goodwin drew attention to the aviation industry's many employees who were nearing retirement and the need for a succession strategy, including education grants to support airport staff training and programs that receive national recognition.

#### The Honourable Peter Styles, NT Minister for Transport

Peter Styles holds a Master of Business Administration degree, a Postgraduate Diploma in Business Studies, and a Diploma in Communication and Media.

He is a Fellow of the Australian Rural Leadership Foundation, a Fellow of the Australian Institute of Company Directors, and a Member of the Australian Institute of Management.

The Minister emphasised civil and defence aviation were the lifeblood of the Top End, generating 2% of the local economy on the back of natural gas, mining, agriculture, and tourism industries. Darwin is known as the 'gateway into Asia' and conversely the 'Asian gateway into Australia'.

In 2013-14, economic growth in the NT is forecast to increase by 5.0%, mainly by fast-tracking the INPEX and Total joint venture, constructing a two-train LNG plant at Blaydin Point near Darwin - the largest project ever undertaken in the Territory.

Also in the pipeline, The Greater Sunrise LNG field and floating production facility shared between Australia and Timor-Leste; Sherwin Iron development of the Roper River iron ore project; and Australian Abrasive Minerals extracting mineral sands near Alice Springs.

#### Ian Kew, CEO Northern Territory Airports

Ian Kew spent 20 years working for the Shell group of energy and petrochemicals companies in a variety of marketing, operations, change management and special project positions and holds an economics degree.

Responsible for aviation development at Darwin, Alice Springs and Tennant Creek Airports; by 2014 Darwin International Airport terminal will have doubled in size and increased its capacity to process 6-million passengers a year.

A 100-hectare site at Alice Springs Airport designated Australia's first 'aircraft bone yard', has been developed as a final resting place for aircraft past their use-by date. The big location and dry conditions will check aircraft corrosion to enable panels and parts to be retrieved for planes still in service.

The plan requires pensioned-off planes to taxi off the runway straight into the location with up to 250 other retired planes, although the facility is still to R.I.P its first aviation body.

Last year, the total number of visitors to the NT increased by 5.2% chiefly more domestic visitors, as against a decline in international visitors attributed to the \$A above parity with \$US and up against the Japanese yen.

As a result, Australia became a relatively more expensive holiday destination, especially for visitors from the traditional Japan and USA markets, at the same time overseas travel for Australians became cheaper.

The completed Darwin International Airport (DIA) terminal extensions will increase passenger and retail capacity and Qantas and Virgin Airlines substantially enlarging their Club lounges.

The biggest project undertaken by DIA since opening in 1991 and will create improved baggage handling systems, security screening, check-in areas and club lounges.

#### Peter Hoefkens, Business Development, Baggage Handling, Vandelande.

Peter Hoefkens presented on the use of robots at Amsterdam Airport Schipol and Heathrow London Heathrow Airport, incorporating smart technology and fewer hands on bags, resulting in increased productivity of operations, speedier turnaround times and greater reliability and accuracy (bags going where they're supposed).

Schipol Airport is at the forefront of automation in baggage handling where luggage is processed through a baggage-on-demand system, where 180,000 bag items daily and (65-million each year) using the Bagstore storage systems and Bagload robot loading.

When bags are dropped off each is bar coded and moves in large trays on a high-speed conveyor system to a stacked storage facility and a call process allows items to be rapidly retrieved and moved to various gates without human intervention.

Turnaround times for international baggage have been reduced from 3hours to 1-hour and indicate one of the benefits of an automated system, as well as fewer hands on bags, the productivity of operators is improved, flexibility is maximised when flight schedules are adjusted and the system is highly reliable and accurate.

With labour predicted to become more scarce and expensive and airport operators required to provide better and more costly workplace facilities, the greater use of smart technology especially automated container handling in airport terminals is inevitable.

### Dr Rafael Echevarne, Director Economics & Program Development, Airports Council International (ACI).

Dr Rafael Echevarne holds a PhD in Air Transport Economics and occupied positions in companies in Europe, Australasia and the Middle East and has been actively involved in air transport economic regulation, privatisation and development of aeronautical infrastructure.

ACI "The voice of the world's airports' represents 573 airports (69% of which are making an operating loss) in 174 countries are processing almost 6-billion passengers a year.

Dr Echevarne reviewed ACI's latest Economic Research Report that presented airport performance through the lens of privatisation and regulatory framework and analysed customer service and the relationship between service and financial performance.

It showed passenger traffic continued to growth in first half of 2013 while there was virtually no increase in freight traffic for the period. Although passenger flow remained positive, growth slowed to 2.9% on  $\Box$  a yearly basis. The slowdown reflects weakening domestic markets in North America and Europe due to economic doubts and softer consumer spending.

At the same, the world's major hub airports continued to offset the developed world slowdown and passenger traffic expanded significantly in: Kuala Lumpur (22.3%), Dubai (17.5%) and Istanbul (12.1%).

With export growth slowed to the advanced economies, the major freight centres in the Asia-Pacific region also experienced the impact, the exception being Hong Kong with modest growth of 1% and Shanghai and Incheon recorded freight volumes declines by 4.1% and 1.7% respectively.

Dr Echevarne said the Euro area recession and slow consumer spending in the European and North American economies caused the loss of momentum in demand for air transport. However emerging markets were ready for continued expansion as they set the pace for growth in demand for passenger travel.

Mr Owen discussed Performance-Based Navigation (PBN) and introduced the Multi-Lateration (MLAT) technology for navigating in terrain from anywhere and arriving on time.

The MLAT cutting edge technology is installed in the mountains surrounding Queenstown, a system that allows control tower staff to accurately know where all aircraft are operating in the area, leading to improved safety and flight reliability for the local community.

The new technology is a first in the Southern hemisphere and enables specially-equipped aircraft to land and takeoff in fog and adverse weather conditions and cost savings associated with aircraft diversions, passenger travel disruptions and flight cancellations have been impressive with MLA.

Looking to 2015 and beyond, Mr Owen predicated a future operating environment where an aircraft's profile will be managed from departure gate to arrival gate.

Current and developing technology and systems will provide the support and capability to allow the Air Traffic Management (ATM) system and its people to deliver improved safety and efficiency.

Aircraft routes will become more efficient, with fewer track miles and less time in the air, however there will be routes within the ideal environment that will have greater flight path distances, but their success will be judged by the outcome that achieves the most fuel-efficient result for the airline.

Infrastructure efficiencies can also be achieved by minimising the number of ground based navigational aids to only those necessary to provide a likely route formation.

Performance Based Navigation (PBN) relies on satellite navigation for more precise flight paths, where the height of aircraft on landing and takeoff will change with airport approaches at 3,000 feet and resulting noise reduction, fuel savings, less CO2 and passenger numbers.

The function of conventional control towers is also under review, whether they are an obstacle to a reliable service or would the virtual towers model, with a bank of workstation CCTV monitors staffed from another location providing 'just in time' services from aircraft approach to landing and then closed, offer a more efficient and cost effective alternative?

#### Dr Simon Denman, Surveillance Stream - Airports of the Future, Queensland University of Technology

Dr Simon Denman is a Research Fellow of Science and Engineering Faculty, Electrical Engineering, Computer Science, Computational Intelligence and Signal Processing with QUT qualifications as PhD, Bachelor of Information Technology, and Bachelor of Engineering.

He helped develop a technique for the simultaneous computation of multi-layer motion segmentation and optical flow and performing research into computer vision areas such as intelligent surveillance, object tracking, soft biometrics and airport security.

The R&D included solutions for improving passenger access and refining security within airports, the passenger experience, navigation and way-finding in terminals.

Intelligent surveillance and automatic information gathering can allow the tracking of persons and objects throughout the terminal, analysis of crowds and queues to identify expected passenger delays, and to also identify irregular human behaviour which may indicate threats to the airport and other passengers.

The Intelligent Surveillance program aims to enhance the human component of visual surveillance through the automatic merging of intelligence acquired from large multi-camera networks, to estimate airport effectiveness and identify important patterns of interest.

The research entails automatic techniques to discover camera calibration information and person tracking by developing multi-layer motion detectors and scalable condensation filters. Research of crowd modeling techniques, such as crowd counting, queue length estimation and crowd event detection, to generate individual tracks and detect emergent properties in passenger behaviour.

An airport is one of the largest and most complex systems in our society, and as passengers are the major customers, airports are becoming more customers orientated and installing new technology to improve their airport experience.

Passenger activities are in two main categories – **processing activities** - those related to the regulation processes including check-in, security screening and immigration. The majority of passenger terminal time is engaged in **discretionary activities** such as duty-free shopping and books, souvenir and gift purchases.

During both these activities the passenger interactions and experiences are researched, analysed and coded to inform the human-centered design of future business operations. The Airport Information Model (AIM) then provides virtual simulation capabilities of current and future passenger activities.

In today's global environment industry stakeholders are mindful of the terrorist threat posed to terminals and having a 3-dimensional visualisation of the terminal as well as information about the building materials can enable blast assessments to be made quickly and accurately by terminal designers and emergency responders.

The Airport Information Model (AIM) integrates information systems on all aspects of airport operations management, asset management, and airport design and planning into a common platform. The system could also be integrated with a merged identity and access management system to ensure that data and physical areas of the terminal are accessible only by authorised personnel.

In a modern airport environment, a large number of personnel from different stakeholder groups require physical access to restricted areas and facilities. Staff also need to use sensitive and critical data systems, including flight information display, travel information management and immigration and baggage handling systems. Therefore access needs to be controlled and accountable for both passengers and airport personnel.

The present dispersal of administrative authority makes user and access management in the airport environment expensive, leading to likely duplication and the potential for error. The main challenge is maintaining up-to-date access rights to personnel when they are first appointed, made redundant or change roles and tasks within the organisation.

The Entry Control Point (ECP) prototype monitors people entering queues, their dwell times, wait times and exit and provides for the smooth running of routine activities and in rearranging passenger flow through fewer interventions and more effective ID verification processes. The advanced reconciliation process being designed will link passengers to their present position, baggage and other supporting data such as travel history and risk profile in real time.

#### Dr Rob Weaver, Executive General Manager, Environment, Airservices Australia.

Dr Weaver oversees Airservices environment management strategy, standards and systems and delivery of environmental services to industry and the community. An experienced Aviation Executive, Leader, Strategist and HSEC Specialist, with practical experience in safety management and environment management and a degree from University of York.

Airservices Australia manages airspace covering 11 per cent of the world's surface, providing air traffic operations for around 63 million passengers on more than 4 million domestic and international flights annually.

Aircraft noise is the most significant cause of adverse community reaction to the operation of airports. Limiting or reducing the number of people affected by significant aircraft noise remains a key environmental goal for AsA and the entire aviation community.

Balancing the sometimes-conflicting goals of minimising noise impacts and assuring reductions in emissions is a worldwide issue. There are several key elements to address aircraft noise problems in an environmentally responsive and economically responsible way including the reduction of noise at source scheduling quieter aircraft and uniform noise standards.

Dr Weaver discussed land-use planning and management playing an important role with attention to zoning, easements and building standards. Incorporating noise abatement operational procedures that favour noise preferred routes and runways and limited engine ground running. As a last resort, imposing operating restrictions on aircraft that would require caps, curfews and quotas.

To achieve the greatest environmental benefit for the Australian aviation industry, AsA works collaboratively with its industry partners, including the airlines, airports & government departments responsible for transport and environment policy & all parts of industry.

Impact reduction initiatives comprise both technological and operational that will improve environmental performance in terms of emissions, as well as noise amelioration programs. However, the technological advances in aircraft navigation systems that enable aircraft to fly tracks more accurately may leave the industry at odds with communities in the vicinity of airports.


It is important that appropriate information is available to communities, and in particular those communities directly impacted by noise.

Initiatives include effective management of change, providing appropriate information to stakeholders about aircraft noise and operations, and effective engagement with stakeholders. AsA acknowledges that Community Aviation Consultation Groups (CACG) is a critical vehicle for these initiatives and is an opportunity for industry stakeholders to work cooperatively with the community.

Airservices WebTrak noise tracking information service provides the 'My Neighbourhood' component which gives public access to information about aircraft noise and operations around eight of Australia's busiest airports (Perth included).

Dr Weaver introduced the updated data system, as a tool that allows public access to aircraft flight activity of over metropolitan areas using a map to display the surrounding suburbs of an airport and the viewer to see information about arriving and departing aircraft.

WebTrak uses information from air traffic control secondary surveillance radars to monitor aircraft up to a height of 30,000 feet and aircraft noise data is downloaded daily from monitors strategically located within communities close to the airport.

#### Margaret Staib, Chief Executive Officer, Airservices Australia

Former Commandant of Australian Defence Force Academy and promoted to air vice marshal and Commander Joint Logistics Command. Awarded OAM for exceptional service to the RAAF and ADF in logistics strategic planning and has a Bachelor of Business and Masters of Arts in Strategic Studies.

Collaborative Decision Making (CDM) principles are applied in many of the industry's existing planning and operational activities including airspace and route planning and current demand and capacity management activities.

CDM requires improving data sharing between airport stakeholders to provide a common operational plan that enables improved turn-around for aircraft, which in turn offers more efficient use of airport infrastructure and resources.

CDM allows all users, including aircraft operators, airports, ground handlers and air traffic control to be aware of limitations, issues and the needs of other users and service providers. The overall effect is a more knowledgeable and involved aviation community that improves services and reduces costs for all users and providers.

CDM will improve planning and resource use through better and more accurate) information sharing, to recover more quickly from adverse conditions, saves costs through reduced fuel burn and aircraft maintenance. The improved planning at a network level will provide a more predictable and reliable service, achieve higher on-time performance, reduce airborne delays and reduce emissions.

CDM reduced costs and emissions come from lower fuel burn, plus less airframe flight time, which also leads to less maintenance costs.

Ground staff are also more productive because aircraft arrival times are known well in advance, with no waiting at the gate for an aircraft to arrive and no aircraft delayed for ground staff to arrive.

Airport operators adopting CDM will be able to reduce tarmac and terminal congestion, improve planning and resource use through better and more accurate information sharing.

The travelling community CDM benefits from fewer flight delays, reduction in aviation emissions and improved safety.

The introduction of CDM (Perth Airport) has seen some aircraft held before departure longer, rather than departing 'on time' and avoiding facing air traffic delays in the air. Aircraft are held from departure until they have a confirmed arrival time at the destination airport.

#### Stephen Byron, Managing Director, New Canberra Airport 'Airvolution'

Stephen Byron has a Bachelor of Laws (Hons) and Bachelor of Commerce and former development manager Capital Property Trust & Capital Property Corporation.

Canberra Airport was named 'Capital City Airport of the Year' at the AAA Airport Industry Awards 2013 for its 'Airvolution' terminal precinct redevelopment costing \$480-million.

The 55,000 square-metre complex comprises four main elements:

Apron: 4 new aircraft parking positions

**Car parks:** 5 new areas with two multi-stories, totaling 3,700 bays

**Terminal:** Check-in counters boosted to 44; baggage handling quadrupled, 10 new aerobridges; expanded security screening; bigger club lounge area; and new retail and catering outlets.

**Roads:** Two-level, dual-lane, axial road system forming the new entry and exit road to the terminal.

The 'Airvolution' passenger experience to create a functional and efficient terminal and for social interaction and a place of calm reflected in the landscaped areas, water features sculptures

The terminal building is environmentally sustainable the roof can harvest 1.3 million litres of water that is used in toilets, air-conditioning and landscape irrigation. Electricity generated on-site from gas and captures waste heat to cool and warm the building, which in turn reduces the building's carbon emissions by 75%.

The Airport's 2014 Master Plan includes a ground transportation plan and proposals linking the Canberra CBD by light rail to Canberra Airport.

Canberra's new airport was named Australian Airport of the Year at the National Airport Industry Awards acknowledging the organisations and individuals who are achieving excellence within Australia's airport industry.

Wayfinding systems have been integrated with the terminal design with colours that are markers for different parts of the passenger journey.

Red is the departure colour, with illuminated red bubble walls at the end of each drop-off point. Yellow is the arrivals colour, with yellow illuminate bubbles at the two arrivals access points, the baggage claim area. Green is used as the information colour, with green markers in the signage stands. Cleaning, security and customer services staff have green on their uniforms - if you need something look for green. Blue colour glass at the perimeter is used to break-up longer corridors to the end aerobridge gate and ground boarding positions.

The protection barrier in front of the terminal is disguised as a designed water feature, with garden beds around it.

Peter Koulos has a Bachelor of Engineering (Electrical, Hons) and experience across a range of projects in Australia, United Kingdom, UAE and Europe and more recently involved in transport projects including Victoria Regional Rail Link packages, Williams Landing Station and Coolaroo Station and BAE Systems Williamstown.

Mr Koulas emphasised the increased focus on energy performance, system life and operational management in airport buildings, means it's critical that strategies are put in place for assessing and identifying opportunities for improved energy management and return on investment on both existing and new buildings.

Almost two-thirds of non-aeronautical revenue is generated through property and retail at airports and most organisations are looking at sustainability in terms of economic, operational, environmental and social benefits.

The one area that offers significant opportunities for improvement is environmental improvement, in areas such as energy, emissions, water, waste and noise.

Any sustainability initiative needs to be financially viable with the capital cost equated against the operational cost and the impacts of retrofitting.

#### Cally Ward, Senior Aviation Consultant, Airbiz Aviation Strategies

As a market researcher, Cally became interested in travel and tourism from working with market research clients in London and the package holiday industry.

With the resources industry driving the Australian economy, what does the mining industry want from aviation and how can every Australian airport leverage from this market to expand their airport business (a case study of the FIFO phenomenon)?

Airbiz has worked with multiple airports in the thriving resources sector and expanding expertise in the FIFO market (Fly In Fly Out) market. It is consistently said FIFO is a mindset and those who excel in the lifestyle share common character traits.

FIFO travellers are strategic thinkers, driven by the financial reward, who choose to live away from resource-rich regions as they value a coastal lifestyle. These people turn to FIFO due to the inconsistency between their desired costal lifestyle and lack of higher paying roles.

Ms Ward observes that to a resource company, air travel is not fun, sexy or a choice, but more a logistical solution required transporting its workforce from home to work, ensuring the on-going operation of its project. The failure of the workforce to arrive means production ceases, which has huge implications for productivity, profitability and the supply chain. The resource industry wants guaranteed flight operations with schedules that fit their roster system and workplace practices, regardless of delays, diversions, aircraft going unserviceable etc. They want fixed and guaranteed costs as part of their financial model and the confidence to know that their staff will be on site when shifts commence.

Ms Ward says the value of the resource industry's air travel business is huge, and it is neither discretionary nor seasonal. Further this market is populated by a relatively few FIFO individuals who travel with very high repeat frequency.

The model for the resource industry is segmented into different travel, however FIFO staff share many similar characteristics, allowing the development of facilities and services straightforward, once their needs and wants are understood.

FIFO traffic is driven by the phase of development, the type of resource, shift pattern of the mine site and changing workplace practices. The trends impacting the FIFO market in the future are likely to include an increase in FIFO at new mine sites, enabling flexibility for the resource company to shut down production when it becomes uneconomic.

An increase in automation and new technology at new mine sites Remote Operations Centres (ROC) requiring fewer on site operational staff. However the likelihood of retrofitting existing mine sites with new technology such a remote operated trucks is limited due to the investment required and potential disruption to existing operations.

There are many different FIFO models, indicating the diverse systems of booking, paying and understanding travel, while regular passenger transport or charter services are used or a mix of both.

Airbiz conducted qualitative research with individual FIFOs and followed them over the course of a year to understand their lives and travel requirements, with regular interviews about their travel planning, experiences at airports and needs and wants.

Although they come from different backgrounds, with diverse skills needed in the resources industry, they share common personality traits and are; ambitious and driven; mature and see the big picture, may relocate for lifestyle and/or whole of family benefit and are motivated by doing their best  $\Box$ 

So what can airports do to capitalise on the resources industry?

All airports should understand that the needs and wants of the resource companies and the FIFOs are different to passengers travelling for leisure and Airbiz identifies broad clusters of airport type, from major population centres to general aviation and every airport has an area it can grow revenue in, through a better understanding of the resource industry travel market.



#### The Honourable Peter Styles, NT Minister for Transport

Peter Styles holds a Master of Business Administration degree, a Postgraduate Diploma in Business Studies, and a Diploma in Communication and Media.

He is a Fellow of the Australian Rural Leadership Foundation; a Fellow of the Australian Institute of Company Directors, and a Member of the Australian Institute of Management.

Emphasised civil and defence aviation were the lifeblood of the Top End, generating

2% of the local economy on the back of natural gas, mining, agriculture and tourism

industries. Darwin is known as the 'gateway into Asia' and conversely the 'Asian

gateway into Australia'.

In 2013-14, economic growth in the NT is forecast to increase by 5.0%, mainly by fast-tracking the INPEX and Total joint venture, constructing a two-train LNG plant at Blaydin Point near Darwin - the largest project ever undertaken in the Territory.

Also in the pipeline, The Greater Sunrise LNG field and floating production facility shared between Australia and Timor-Leste; Sherwin Iron development of the Roper River iron ore project; and Australian Abrasive Minerals extracting mineral sands near Alice Springs.

#### Ian Kew, CEO Northern Territory Airports

Ian Kew spent 20 years working for the Shell group of energy and petrochemicals companies in a variety of marketing, operations, change management and special project positions and holds an economics degree from Monash University.

Responsible for aviation development at Darwin, Alice Springs and Tennant Creek Airports by 2014 the Darwin International Airport terminal (under construction) will double in size and increase the facility's capacity to handle 6-million passengers annually.

A 100-hectare site at Alice Springs Airport designated Australia's first 'aircraft bone yard', has been developed as a final resting place for aircraft past their use-by date. The big location and dry conditions will check aircraft corrosion to enable panels and parts to be retrieved for planes still in service.

The plan requires pensioned-off planes to taxi off the runway straight into the location with up to 250 other retired planes, although the facility is still to R.I.P its first aviation body.

Last year, the total number of visitors to the NT increased by 5.2% chiefly more domestic visitors, as against a decline in international visitors attributed to the \$A above parity with \$US and up against the Japanese yen.

As a result, Australia became a relatively more expensive holiday destination, especially for visitors from the traditional Japan and USA markets, at the same time overseas travel for Australians became cheaper. The completed Darwin International Airport (DIA) terminal extensions will increase passenger and retail capacity and Qantas and Virgin Airlines substantially enlarging their Club lounges.

The biggest project undertaken by DIA since opening in 1991 and will double the terminal size, create room for improved baggage systems, security screening and check-in areas, and club lounges.

# Peter Hoefkens, Business Development – Baggage Handling, Vandelande.

Peter Hoefkens presented on the use of robots at Amsterdam Airport Schipol and Heathrow London Heathrow Airport, incorporating smart technology and fewer hands on bags, resulting in increased productivity of operations, speedier turnaround times and greater reliability and accuracy (bags going where they're supposed).

Schipol Airport is at the forefront of automation in baggage handling where luggage is processed through a baggage-on-demand system, where 180,000 bag items daily and (65-million each year) using the Bagstore storage systems and Bagload robot loading.

When bags are dropped off each is bar coded and moves in large trays on a high-speed conveyor system to a stacked storage facility and a call process allows items to be rapidly retrieved and moved to various gates without human intervention.

Turnaround times for international baggage have been reduced from 3-hours to 1-hour and indicate one of the benefits of an automated system, as well as fewer hands on bags, the productivity of operators is improved, flexibility is maximised when flight schedules are adjusted and the system is highly reliable and accurate.

With labour predicted to become more scarce and expensive and airport operators required to provide better and more costly workplace facilities, the greater use of smart technology especially automated container handling in airport terminals is inevitable.

# Dr Rafael Echevarne, Director Economics & Program Development, Airports Council International (ACI).

Dr Rafael Echevarne holds a PhD in Air Transport Economics and occupied positions in companies in Europe, Australasia and the Middle East and has been actively involved in air transport economic regulation, privatisation and development of aeronautical infrastructure.

ACI "The voice of the world's airports' represents 573 airports (69% of which are making an operating loss) in 174 countries are processing almost 6-billion passengers a year.

Dr Echevarne reviewed ACI's latest Economic Research Report that presented airport performance through the lens of privatisation and regulatory framework and analysed customer service and the relationship between service and financial performance.

It showed passenger traffic continued to growth in first half of 2013 while there was virtually no increase in freight traffic for the period. Although passenger flow remained positive, growth slowed to 2.9% on a yearly basis. The slowdown reflects weakening domestic markets in North America and Europe due to economic doubts and softer consumer spending. At the same, the world's major hub airports continued to offset the developed world slowdown and passenger traffic expanded significantly in: Kuala Lumpur (22.3%), Dubai (17.5%) and Istanbul (12.1%).

With export growth slowed to the advanced economies, the major freight centres in the Asia-Pacific region also experienced the impact, the exception being Hong Kong with modest growth of 1% and Shanghai and Incheon recorded freight volumes declines by 4.1% and 1.7% respectively.

Dr Echevarne said the Euro area recession and slow consumer spending in the European and North American economies caused the loss of momentum in demand for air transport. However emerging markets were ready for continued expansion as they set the pace for growth in demand for passenger travel.

#### Gareth Owen, Head Commercial & Customer Relation, Airways NZ

Gareth Owen is responsible for Strategy, Pricing, Product Development and Customer Relations. With a background in Aviation, Travel and Energy, he held executive and senior management marketing roles with Christchurch International Airport, Hertz and Europcar.

Discussed Performance-Based Navigation (PBN) and introduced Multi-Lateration (MLAT) technology for navigating in terrain from anywhere and arriving on time. The MLAT cutting edge technology is installed in the mountains surrounding Queenstown, a system that allows control tower staff to accurately know where all aircraft are operating in the area, leading to improved safety and flight reliability for the local community.

The new technology is a first in the Southern hemisphere and enables specially-equipped aircraft to land and takeoff in fog and adverse weather conditions and cost savings associated with aircraft diversions, passenger travel disruptions and flight cancellations have been impressive with MLA

Looking to 2015 and beyond, Mr Owen predicated a future operating environment where an aircraft's profile will be managed from departure gate to arrival gate.

Current and developing technology and systems will provide the support and capability to allow the Air Traffic Management (ATM) system and its people to deliver improved safety and efficiency outcomes.

Aircraft routes will become more efficient, with fewer track miles and less time in the air, however there will be routes within the ideal environment that will have greater flight path distances, but their success will be judged by the outcome that achieves the most fuelefficient result for the airline.

Infrastructure efficiencies can also be achieved by minimising the number of ground based navigational aids to only those necessary to provide a likely route formation.

Performance Based Navigation (PBN) relies on satellite navigation for more precise flight paths, where the height of aircraft on landing and takeoff will change with airport approaches regularly at 3,000 feet and resulting noise reduction, fuel savings, less CO2 and passenger numbers and airport revenue increased.

The function of conventional control towers is also under review, whether they are an obstacle to a reliable service or would the virtual towers model, with a bank of workstation CCTV monitors staffed from another location providing 'just in time' services from aircraft approach to landing and then closed, offer a more efficient and cost effective alternative?

# Dr Simon Denman, Surveillance Stream - Airports of the Future, Queensland University of Technology

Dr Simon Denman is a Research Fellow of Science and Engineering Faculty, Electrical Engineering, Computer Science, Computational Intelligence and Signal Processing with QUT qualifications as PhD, Bachelor of Information Technology, Bachelor of Engineering (Electronics).

Dr Denman helped develop a technique for the simultaneous computation of multi-layer motion segmentation and optical flow and performing research into computer vision areas such as intelligent surveillance, object tracking, soft biometrics and airport security. The R&D included solutions for improving passenger access and refining security within airports, the passenger experience, navigation and way-finding in terminals.

Intelligent surveillance and automatic information gathering can allow the tracking of persons and objects throughout the terminal, analysis of crowds and queues to identify expected passenger delays, and to also identify irregular human behaviour which may indicate threats to the airport and other passengers.

The Intelligent Surveillance program aims to enhance the human component of visual surveillance through the automatic merging of intelligence acquired from large multi-camera networks, to estimate airport effectiveness and identify important patterns of interest which are directly related to collective enterprise function and emergent properties. The research entails automatic techniques to discover camera calibration information and person tracking by developing multi-layer motion detectors and scalable condensation filters. Research of crowd modelling techniques such as crowd counting, queue length estimation and crowd event detection, to generate individual tracks and detect emergent properties in passenger behaviour.



#### Automated crowd counting.

An airport is one of the largest and most complex systems in our society and as passengers are the major customers, airports are becoming more customers orientated and installing new technology to improve their airport experience.

Passenger activities are in two main categories – **processing activities** - those related to the regulation processes including checkin, security screening and immigration. The majority of passenger terminal time is engaged in **discretionary activities** such as dutyfree shopping and books, souvenir and gift purchases.

During both these activities the passenger interactions and experiences are researched, analysed and coded to inform the humancentred design of future business operations. The Airport Information Model (AIM) then provides virtual simulation capabilities of current and future passenger activities.

In today's global environment industry stakeholders are mindful of the terrorist threat posed to terminals and having a 3-dimensional visualisation of the terminal as well as information about the building materials can enable blast assessments to be made quickly and accurately by terminal designers and emergency responders.

The Airport Information Model (AIM) integrates information systems on all aspects of airport operations management, asset management, and airport design and planning into a common platform. The system could also be integrated with a merged identity and access management system to ensure that data and physical areas of the terminal are accessible only by authorised personnel. In a modern airport environment, a large number of personnel from different stakeholder groups require physical access to restricted areas and facilities. Staff also need to use sensitive and critical data systems, including flight information display, travel information management and immigration and baggage handling systems. Therefore access needs to be controlled and accountable for both passengers and airport personnel.

The present dispersal of administrative authority makes user and access management in the airport environment expensive, leading to likely duplication and the potential for error. The main challenge is maintaining up-to-date access rights to personnel when they are first appointed, made redundant or change roles and tasks within the organisation.

The Entry Control Point (ECP) prototype monitors people entering queues, their dwell times, wait times and exit and provides for the smooth running of routine activities and in rearranging passenger flow through fewer interventions and more effective ID verification processes. The advanced reconciliation process being designed will link passengers to their present position, baggage and other supporting data such as travel history and risk profile in real time.

#### Dr Rob Weaver, Executive General Manager, Environment, Airservices Australia

Experienced Aviation Executive, Leader, Strategist and HSEC Specialist, with practical experience in safety management and environment management, holds degree from University of York.

Airservices Australia manages airspace covering 11 per cent of the world's surface, providing air traffic operations for around 63 million passengers on more than 4 million domestic and international flights annually.

Aircraft noise is the most significant cause of adverse community reaction to the operation of airports. Limiting or reducing the number of people affected by significant aircraft noise remains a key environmental goal for AsA and the entire aviation community.

Balancing the sometimes-conflicting goals of minimising noise impacts and assuring reductions in emissions is a worldwide issue. There are several key elements to address aircraft noise problems in an environmentally responsive and economically responsible way including the reduction of noise at source scheduling quieter aircraft and uniform noise standards. Dr Weaver discussed land-use planning and management playing an important role with attention to zoning, easements and building standards. Incorporating noise abatement operational procedures that favour noise preferred routes and runways and limited engine ground running. As a last resort, imposing operating restrictions on aircraft that would require caps, curfews and quotas.

To achieve the greatest environmental benefit for the Australian aviation industry, AsA works collaboratively with its industry partners, including the airlines, airports and government departments responsible for transport and environment policy and all parts of industry.

Impact reduction initiatives comprise both technological and operational that will improve environmental performance in terms of emissions, as well as noise amelioration programs. However, the technological advances in aircraft navigation systems that enable aircraft to fly tracks more accurately may leave the industry at odds with communities in the vicinity of airports.


It is important that appropriate information is available to communities, and in particular those communities directly impacted by noise.

Initiatives include effective management of change, providing appropriate information to stakeholders about aircraft noise and operations, and effective engagement with stakeholders. AsA acknowledges that Community Aviation Consultation Groups (CACG) is a critical vehicle for these initiatives and is an opportunity for industry stakeholders to work cooperatively with the community.

Airservices WebTrak noise tracking information service provides the 'My Neighbourhood' component which gives public access to information about aircraft noise and operations around eight of Australia's busiest airports (Perth included).

Dr Weaver introduced the updated data system, as a tool that allows public access to aircraft flight activity of over metropolitan areas using a map to display the surrounding suburbs of an airport and the viewer to see information about arriving and departing aircraft.

WebTrak uses information from air traffic control secondary surveillance radars to monitor aircraft up to a height of 30,000 feet and aircraft noise data is downloaded daily from monitors strategically located within communities close to the airport.

#### Margaret Staib, Chief Executive Officer, Airservices Australia

Former Commandant of Australian Defence Force Academy and promoted to air vice marshal and Commander Joint Logistics Command. Awarded OAM for exceptional service to the RAAF and ADF in logistics strategic planning and has a Bachelor of Business and Masters of Arts in Strategic Studies.

Collaborative Decision Making (CDM) principles are applied in many of the industry's existing planning and operational activities including airspace and route planning and current demand and capacity management activities.

CDM requires improving data sharing between airport stakeholders to provide a common operational plan that enables improved turn-around for aircraft, which in turn offers more efficient use of airport infrastructure and resources. CDM allows all users, including aircraft operators, airports, ground handlers and air traffic control to be aware of limitations, issues and the needs of other users and service providers. The overall effect is a more knowledgeable and involved aviation community that improves services and reduces costs for all users and providers.

CDM will improve planning and resource use through better and more accurate) information sharing, to recover more quickly from adverse conditions, saves costs through reduced fuel burn and aircraft maintenance.

The improved planning at a network level will provide a more predictable and reliable service, achieve higher on-time performance, reduce airborne delays and reduce emissions.

CDM reduced costs and emissions come from lower fuel burn, plus less airframe flight time, which also leads to less maintenance costs.

Ground staff are also more productive because aircraft arrival times are known well in advance, with no waiting at the gate for an aircraft to arrive and no aircraft delayed for ground staff to arrive.

Airport operators adopting CDM will be able to reduce tarmac and terminal congestion, improve planning and resource use through better and more accurate information sharing

The travelling community CDM benefits from fewer flight delays, reduction in aviation emissions and improved safety.

The introduction of CDM (Perth Airport) has seen some aircraft held before departure longer, rather than departing 'on time' and avoiding facing air traffic delays in the air. Aircraft are held from departure until they have a confirmed arrival time at the destination airport.

# Stephen Byron, Managing Director, New Canberra Airport 'Airvolution'

Canberra Airport was named 'Capital City Airport of the Year' at the AAA Airport Industry Awards 2013 for its 'Airvolution' terminal precinct redevelopment costing \$480-million.

The 55,000 square-metre complex comprises four integrated elements:

Apron: 4 new aircraft parking positions,

Car parks: 5 new areas with two multi-stories, totalling 3,700 bays Terminal: Check-in counters boosted to 44; baggage handling quadrupled, 10 new aerobridges; expanded security screening; bigger club lounge area; and new retail and catering outlets.
Roads: A two-level, dual-lane, axial road system forming the new entry and exit road to the terminal.

The 'Airvolution' passenger experience to create a functional and efficient terminal and for social interaction and a place of calm reflected in the landscaped areas, water features sculptures

The terminal building is environmentally sustainable the roof can harvest 1.3 million litres of water that is used in toilets, airconditioning and landscape irrigation. Electricity generated on-site from gas and captures waste heat to cool and warm the building, which in turn reduces the building's carbon emissions by 75%.

The Airport's 2014 Master Plan includes a ground transportation plan and proposals linking the Canberra CBD by light rail to Canberra Airport.

Canberra's new airport was named Australian Airport of the Year at the National Airport Industry Awards acknowledging the organisations and individuals who are achieving excellence within Australia's airport industry.

Wayfinding systems have been integrated with the terminal design with colours that are markers for different parts of the passenger journey.

Red is the departure colour, marked by the illuminated red bubble walls at the end of each drop-off point. Yellow is the arrivals colour, marked by the large yellow illuminate bubble all at the two arrivals access points to the baggage claim area and then is reinforced with the baggage claim signage elements and yellow elements within the light fittings themselves. Green is used as the information colour, with green markers in the signage plinths. The cleaning staff, security staff and customer services staff all have green on their uniforms, the idea being if you need something look for green. Blue colour glass at the perimeter is used to break-up the longer corridors accessing the end aerobridge gate and ground boarding positions.

The protection barrier in front of the terminal is disguised by designing the water features and garden beds around it.

#### Peter Koulos, Director Transport, Norman Disney Young

Peter Koulas emphasised the increased focus on energy performance, system life and operational management in airport buildings, means it's critical that strategies are put in place for assessing and identifying opportunities for improved energy management and return on investment on both existing and new buildings.

Almost two-thirds of non-aeronautical revenue is generated through property and retail at airports and most organisations are looking at sustainability in terms of economic, operational, environmental and social benefits.

The one area that offers significant opportunities for improvement is environmental improvement, in areas such as energy, emissions, water, waste and noise.

Any sustainability initiative needs to be financially viable with the capital cost equated against the operational cost and the impacts of retrofitting

# Cally Ward, Senior Aviation Consultant, Airbiz Aviation Strategies

As a market researcher, Cally became interested in travel and tourism from working with market research clients in London and the package holiday industry.

With the resources industry driving the Australian economy, what does the mining industry want from aviation and how can every Australian airport leverage from this market to expand their airport business (a case study of the FIFO phenomenon)?

Airbiz has worked with multiple airports in the thriving resources sector and expanding expertise in the FIFO market (Fly In Fly Out) market. It is consistently said FIFO is a mindset and those who excel in the lifestyle share common character traits.

FIFO travellers are strategic thinkers, driven by the financial reward, who choose to live away from resource-rich regions as they value a coastal lifestyle. These people turn to FIFO due to the inconsistency between their desired costal lifestyle and lack of higher paying roles.

Ms Ward observes that to a resource company, air travel is not fun, sexy or a choice, but more a logistical solution required transporting its workforce from home to work, ensuring the on-going operation of its project. The failure of the workforce to arrive means production ceases, which has huge implications for productivity, profitability and the supply chain.

The resource industry wants guaranteed flight operations with schedules that fit their roster system and workplace practices, regardless of delays, diversions, aircraft going unserviceable etc. They want fixed and guaranteed costs as part of their financial model and the confidence to know that their staff will be on site when shifts commence.

Ms Ward says the value of the resource industry's air travel business is huge, and it is neither discretionary nor seasonal. Further this market is populated by a relatively few FIFO individuals who travel with very high repeat frequency.

The model for the resource industry is segmented into different travel, however FIFO staff share many similar characteristics, allowing the development of facilities and services straightforward, once their needs and wants are understood.

FIFO traffic is driven by the phase of development, the type of resource, shift pattern of the mine site and changing workplace practices. The trends impacting the FIFO market in the future are likely to include an increase in FIFO at new mine sites, enabling flexibility for the resource company to shut down production when it becomes uneconomic. An increase in automation and new technology at new mine sites Remote Operations Centres (ROC) requiring fewer on site operational staff. However the likelihood of retrofitting existing mine sites with new technology such a remote operated trucks is limited due to the investment required and potential disruption to existing operations.

There are many different FIFO models, indicating the diverse systems of booking, paying and understanding travel, while regular passenger transport or charter services are used or a mix of both.

Airbiz conducted qualitative research with individual FIFOs and followed them over the course of a year to understand their lives and travel requirements, with regular interviews about their travel planning, experiences at airports and needs and wants.

Although they come from different backgrounds, with diverse skills needed in the resources industry, they share common personality traits and are; ambitious and driven; mature and see the big picture, may relocate for lifestyle and/or whole of family benefit and are motivated by doing their best

So what can airports do to capitalise on the resources industry?

All airports should understand that the needs and wants of the resource companies and the FIFOs are different to passengers travelling for leisure and Airbiz identifies broad clusters of airport type, from major population centres to general aviation and every airport has an area it can grow revenue in, through a better understanding of the resource industry travel market.





I have attached two documents signed by the nominated neighbourhood representative and signatory on these two issues confirming the outcome of our discussions.


We have advised Mr Preston and Mr Coad that we will attend to these changes as soon as possible.



f. We do not believe our customers will drop any significant amounts of litter. Bins are provided within the store and only a very small % of customers remain in the vicinity to eat their Pizza. The majority of customers take the Pizza away to eat at home.

g. Crust Pizza is a premium product with the emphasis on quality fresh ingredients and good service. We believe the increased lighting, people, movement and vibrancy etc will actually help the surrounding neighbourhood. The owners of the adjoining cafe actually told us last week they were too frightened to work late in their own shop. They were looking forward to another tenancy opening up.

# **Executive Summary**

The City of South Perth (the City) provides a variety of waste management services which include kerbside commingled recycling and refuse collections, bulk verge collections and the Collier Park Waste Transfer Station (CPWTS) for community drop-off.

As part of standard periodic internal processes, the City has commissioned Talis Consultants Pty Ltd (Talis) to undertake a review of the City's waste management practices including the CPWTS and bulk verge collection activities. This report outlines the work completed as part of the review process, the key findings and Talis' recommendations going forward.

#### Collier Park Waste Transfer Station (CPWTS)

The City owns and operates the CPWTS which provides a waste management service for the residents and small commercial organisations to dispose of waste and recyclables. Over the last 15 years, the CPWTS has seen a continued decrease in tonnages handled and currently receives 1,470 tonnes per year. However, the cost of service has continued to rise and in 2011-12 was \$470,390.

Talis has identified several challenges and issues that are contributing factors to the performance of the CPWTS. The CPWTS has experienced a gradual decline in waste volumes received at the facility since the 1996-97 financial year. Key factors for this include the introduction of the bulk verge and kerbside collection services. Therefore, the City should consider options to maximise tonnage through the CPWTS. An improved advertising and education strategy should increase users to the CPWTS, hence generate greater waste volumes and therefore result in the CPWTS.

The facility is open from 9am to 4:45pm every day. Talis has identified that the CPWTS has operational hours which are uncommon for a facility of that size and volume. Therefore, the hours are considered excessive for a facility of this nature and scale and should be revised. However, the City should make sure that a reduction in operational hours does not significantly reduce the waste volumes currently received at the facility.

The CPWTS is one of the oldest waste transfer stations in the Perth Metropolitan Area and being reflective of the waste management industry at the time, was set up as a waste disposal facility. The report *Collier Park Transfer Station – Redesign Options Investigation (2010)* (Redesign Report) concludes with recommendations that support the transformation of the CPWTS from a disposal based facility to a modern community reuse and recycling centre. Talis support the implementation of the recommendations outlined within the Redesign Report.

#### **Bulk Verge Collection Service**

The City introduced the bulk verge collections for residents in 1998 and utilisation has steadily increased. The City currently provides two combined bulk verge collection services per annum to its residents which includes the collection of greenwaste and hard wastes. The bulk verge collections are undertaken across six areas of the City, each differing in geographic size and population. The City provides advertising and education material in the form of brochures and calendars which are provided with the annual rates notice issued to residents. The advertising and education material outlines the collection areas and guidelines for bulk verge practice requirements.

Recently, the bulk verge collection service has continued to gain in popularity with approximately 2,000 tonnes collected in 2010-11. The increasing tonnages have resulted in a significant cost

escalation in the last five years. The cost of service for the bulk verge collection was \$491,000 in 2011-12.

Talis identified several challenges and issues associated with the bulk verge collection service including the frequent abuse by residents who dispose of greater than permitted volumes and do not separate waste streams.

The City is one of only five local governments, in the Perth Metropolitan Area, that provides two combined bulk verge collections per annum. The most common approach to bulk verge collections is separate greenwaste and separate hard waste services provided at different times. It is anticipated that if the City adopt separate collections this should resolve several of the issues and challenges currently being experienced.

The current collection route starts in Area 1 and finishes within Area 6. Each area is a different geographic and population size with the larger areas requiring additional time to be collected, which in-turn, causes delays within the subsequent collection areas due to the knock on effect. It is anticipated that this will diminish with separate collections. However, if timing issues continue to exist a rearrangement of the order of collection areas may resolve this issue.

The City currently advertises the bulk verge collection in a dedicated pamphlet and on the website. The City also advertises the service in the waste and recycling calendar that is issued annually. Best practice for waste advertising media and strategy, is to be simplistic, concise and easily understood. Talis has identified, that the current terminology utilised by the City is potentially misleading and not reaching the renters and transient population within the City. Continued non-compliances of the bulk verge collection guidelines are apparent which may be a result of the current advertisement and education activities.

It is evident that the City has limited resources and capabilities to police the bulk verge collection service, due to the continued non-compliances encountered. Enforcement Officers should be seen more often inspecting bulk verge wastes and enforcing non-compliances. In the event that the City wishes to implement significant reforms to the bulk verge collection service in the future, policing will play an important role in ensuring participation is undertaken in accordance with the proposed new systems.

There are a number of identified problem areas within the City which prove difficult for the collection Contractor to undertake the bulk verge collection. These areas include residences along Canning Highway and Manning Road, student accommodation, state housing and multi-unit dwellings.

It is anticipated that an alternative collection system could be implemented to resolve the issues and challenges within the identified problem areas.

Based on Talis' review and assessment of the bulk verge collection service and CPWTS, the following recommendations were developed.

#### **Recommendations**

- 1. Develop and implement a targeted Waste Management Advertising and Education Strategy covering all waste management services offered by the City.
- 2. Investigate the distribution of tipping vouchers and advertising materials to the residents of the City as opposed to the home owners.

- 3. Consider a free disposal day/weekend for residents to introduce new users to the facility. This should coincide with the potential reforms of other related services such as the bulk verge collection.
- 4. Examine the option of introducing a trailer rental system at the CPWTS to increase patronage.
- 5. Further investigate opportunities to receive waste from neighbouring local governments, particularly the Town of Victoria Park.
- 6. Investigate opportunities to accept greater tonnages of commercial waste including:
  - Commercial/industrial areas;
  - Educational institutions;
  - Health care facilities;
  - Shopping centres; and
  - Management service companies of retirement villages.
- 7. Investigate an alternate entry and disposal system such as a swipe card system, booking system or special entry times for commercial Contractors in the event that operational hours are unsuitable. This may allow for the operational hours to be further reduced.
- 8. Revise the operational hours to provide greater flexibility for the community to utilise the CPWTS. Due consideration should be given to broader operational aspects such as staffing requirement and Public Holidays as part of this process.
- 9. Investigate opportunities to advance the CPWTS in accordance with the Redesign Options Report.
- 10. Implement greenwaste and hard waste bulk verge collections at separate times.
- 11. Subject to Recommendation 10 consider a revised collection route for the bulk verge collection service.
- 12. Amend terminology currently utilised within the bulk verge collection service advertising material and all future advertising material.
- 13. Specify within the Contract consultation with the Contractor in the generation of the bulk verge collection services advertising material.
- 14. Ensure that waste advertising activities are undertaken in accordance with the Waste Management Advertising and Education Strategy prior to the implementation of the reforms.
- 15. Review compliance and enforcement resources and strategies during the bulk verge collection service.
- 16. Emphasise policing, enforcement and the penalties associated with non-compliance within the targeted Waste Advertising and Education Strategy.
- 17. Monitor the success of the bulk verge collection service reform options proposed in this Report on the identified problem areas. If current issues continue, further investigate alternative bulk verge collection systems for the problem areas.

#### Opening

The Deputy Mayor opened the Councillors' Briefing Forum at 5.40 pm and welcomed everyone in attendance.

#### I. Draft Public Art Strategy

#### **Topics Discussed**

Arts and Events Coordinator – S Bruni

- 1. What is public art outlined the different types and provided definitions and an explanation of the difference between public art and the City's art collection;
- 2. What is the purpose of public art social, economic benefits;
- 3. Why the strategy has been developed;
- 4. How the City acquires art outlined the various methods including City commissioned/funded projects; private developers; donated pieces and temporary artworks advised that there are 22 public art pieces in the City of South Perth;
- 5. Percentage for art outlined what is proposed in terms of private developers;
- 6. Managing the public art process outlined the process including 5 year condition inspections; outlined the proposal to establish a Public Art Advisory Committee and an operational team to support and manage public art projects. Advised that a maintenance fund needs to be established for public art;
- 7. Promoting the City's assets outlined various methods to promote the public art collection to the community;
- 8. Developing the public art collection outlined existing or future projects that the City is undertaking plus highlighted some other projects that could have a public art component;
- 9. Future opportunities including purchasing public art pieces'; placing art pieces in areas of the City that are lacking artworks; including playgrounds and street furniture; involve local businesses; or lease pieces; and
- 10. Strategies provided an overview of the proposed strategies in the draft Public Art Strategy.

**Note:** Members raised questions and points of clarifications which were responded to by the officers.

Topics discussed included: suggestions including swapping/shared art works with other local governments including entry statements (Cr Reid & Lawrance); how public art will be valued/depreciated or appreciated in value (Cr Hasleby); ideas for involving the community in the process (Cr Reid & McMullen); concern that a developer contributions may be a barrier for developers to build in the City as it could be seen as a 'tax' on them (Cr Cridland).

#### Actions/Outcome

Manager Community Culture and Recreation requested that elected members forward any additional feedback and comments on the draft Public Art Strategy through to herself or the Arts and Events Coordinator. The strategy will then be tabled in a council report in the near future (October/November).



#### 2. Waste Management

#### **Topics Discussed**

Manager Engineering Infrastructure – L Croxford

- 1. Household General Waste Collection and Disposal An overview of tonnes collected, method of disposal, specific contract rates and overall cost per tonne was presented.
- 2. Household Recycling Collection and Processing Reference was made to the statistics showing that recycling tonnes over the past three years had remained relatively static while overall tonnes had increased with population increase. With the cost per tonne for recycling about two thirds the household collection rate there is an opportunity to obtain cost efficiencies through educating residents/owners to limit the potential recyclables from being placed in the general bin.
- 3. Street and Public Places Collection and Disposal An essential and frequent service with limited tonnes collected. Represents less than 6% of the Waste Management Budget but equates to a unit rate nearly four times the unit cost for Household General collection.
- 4. Commercial Collection and Disposal A service that requires a disproportionate amount of administrative time and in general much better serviced direct by Private Contractors who have greater flexibility to assign resources based on need rather than through the constraints of a formal tender.
- 5. Biannual Verge side Collection and Disposal –The two combined services undertaken in previous years have increased at a rate greater than expected CPI and had the potential in 2013/14 to be just under \$0.5Million. The Consultants had suggested separating the service into one green waste and one hard waste collection each year in line with the general trend in the metropolitan area. This was suggested as the means of overcoming the experiences of March 2013 and the unprecedented quantities collected and to limit the escalating cost of the service.
- 6. The Collier Park Waste Transfer Station (CPWTS) including separation of the waste stream and disposal. Waste Collection and Disposal costs about \$5.3Million a year. Of all the rubbish services undertaken the transfer station operation is the only one with the potential to offset some of the costs of the service by way of a usage fee structure. Much greater use of the facility is a possibility with changes required in operating hours and a streamlining of the fee structure.
- 7. Talis Consultants Pty Ltd "Waste Management Services Review". The Consultants commissioned to undertake a Review of the CPWTS operations and bulk verge side collections and to identify and to evaluate reform options have now completed the review. An overview of the Consultant's report was presented with the explanation that the Review would be the subject of a Report to Council in October.
- 8. Rivers Regional Council (RRC). A brief overview of the alternative waste treatment options previously considered by RRC and reference made to now move forward with the "waste to energy option" for the household general household waste from the "green top" bin.

Note: Members raised questions and points of clarifications which were responded to by the officers.

#### Actions/Outcome

The Talis Consultants "Waste Management Services Review" will be referenced in the October Council Report as an executive Summary only while the full content of the Review will be included on I-Council and a hard copy placed in the Councillors lounge. The Report to Council will be prepared by the Manager Engineering Infrastructure.

# Policy P211 Water Sensitive Urban Design

#### **POLICY OBJECTIVES**

The City of South Perth is a progressive local government with a primary objective to deliver quality social, economic and environmental services for the wellbeing of its community and employees now and into the future. This also extends to assisting and facilitating the South Perth community in making more sustainable and environmentally responsible choices, including Water Sensitive Urban Design (WSUD).

The objective of this Policy is to:

- Integrate the management of the total water cycle in the urban environment (typically referred to as Water Sensitive Urban Design (WSUD)). WSUD incorporates all water resources, including surface water, groundwater, urban and roof runoff and wastewater.
  - Employ the key principles of WSUD, including:
    - Protect and enhance natural systems and ecological processes,
    - Protect water quality of surface and ground waters,
    - Migration of peak flows to natural background rates;
    - Integrate stormwater treatment into the landscape,
    - Reducing potable water demand,
    - Minimise wastewater generation,
    - · Protect the built environment from flooding and water logging, and
    - Retain, use and infiltrate stormwater at source.
- Assist in the protection and/or enhancement of the environmental values of the Swan and Canning Rivers and watercourses, consistent with the requirements of the Swan and Canning Rivers Management Act 2006;
- Protect, and where possible, restore and enhance the environmental, economic and social (for example recreation and scenic) values of the City's waterways and protected wetlands;
- Implement WSUD best management practices for all new development proposals and City operations.

#### POLICY SCOPE

This Policy applies to all development that occurs within the City of South Perth, including, rezoning, structure plans, subdivisions, and development proposals; and is applicable to all activities, works, services and programs conducted by the City, its contractors, consultants and volunteers.

This Policy shall not bind the Council in respect of any application for planning approval but the Council shall have due regard to the provisions of the Policy and the objectives which the planning policy is designed to achieve before making its decision.

The Water Sensitive Urban Design Guidelines for the City of South Perth is the technical document which supports and forms part of this Policy, and must be read in conjunction with this Policy.

#### **POLICY STATEMENT**

The City acknowledges that urban development disrupts the natural water cycle and **Attachment in terms of the quantity and quality of water**.

The Water Sensitive Urban Development Guidelines for the City of South Perth is the technical document that has been prepared to support this Policy and provide information to those proposing to undertake development and works activities within the City of South Perth.

The WSUD principles are derived from the Department of Water's core goals for water management throughout Western Australia. These goals ensure that:

- The water needs for Perth's population and economic growth are sustainably met;
- Western Australia has contemporary and adaptive water management; and
- · Western Australia exceeds national standards in water efficiency and demand management.

To meet the desired WSUD outcomes, the guidelines contain specific water management objectives and targets for all parts of the urban water cycle. Additionally, guidance is provided on how best to incorporate and design WSUD measures into urban developments to achieve these targets dependent on the size, type and complexity of development.

Detail on a range of best management practice WSUD measures that can be adapted for use within the City of South Perth can be found in the Water Sensitive Urban Design Guidelines for the City of South Perth and the Department of Water Stormwater Management Manual for WA.

The City will encourage innovation and creativity in the uptake of WSUD measures and will move toward supporting and recognising best practice (and beyond) initiatives wherever possible.

#### Structural WSUD Best Management Practices

There are opportunities to incorporate structural best management practices at the structure planning or subdivision stage of development, in order to incorporate WSUD measures into regional and precinct elements.

Many structural measures are scalable and can be easily applied to single lots – refer to the Site Element measures listed in the table below.

The City has developed a list of design criteria for WSUD measures for different types and scales of developments, ranging from single dwelling to subdivision, open spaces and commercial sites. This table outlines potential application of some of these measures for different development types/ elements.
