# **Special Electors' Meeting Minutes**

Minutes of the Special Electors' Meeting held in the Council Chamber, Sandgate Street, South Perth Monday 14 July 2014 at 5:30 pm.

#### I. DECLARATION OF OPENING / ANNOUNCEMENT OF VISITORS

#### I.I Welcome

The Mayor opened the meeting at 7.12 pm and welcomed everyone in attendance with a special welcome to the Councillors and Mr John McGrath MLA (Member for South Perth) and introduced the City's Officers. She then acknowledged the Noongar / Bibbulmun people as the traditional custodians of the land

The Mayor read aloud the City's Disclaimer.

#### 1.2 Mayor's Statement

The Mayor requested that all mobile phones be turned off or on to silent. She then advised that the City's Standing Orders Local Law will apply to the running of the meeting and outlined the following points in relation to proceedings:

- Speakers will be invited to make comment and ask questions. Those who submitted
  presentations and questions prior to the meeting will be invited first. Each speaker to
  restrict their comments to the subject of the meeting and will be allowed no more than 5
  minutes.
- Councillors are not obliged to attend Special Electors' Meetings but have chosen to do so
  to listen to the comments made by the residents of South Perth. Councillors will not
  respond to any questions.
- Only Electors can speak or vote at the meeting. Any Councillor wishing to speak does so as an Elector.
- Speakers should not repeat comments / points already raised by another speaker. There will be the opportunity to voice support in the vote when any Motion is put.
- Council is not bound by any decision made at the meeting. Motions passed will be considered by Council at future meetings.
- Meeting protocol will be adhered to.

#### 2.2 Electors

There were approximately 59 members of the public present.

#### 3. PETITION

The Mayor stated that the meeting has been called in response to a Petition served by Mr Phil Watson, of 25 Norton Street, South Perth together with 141 signatures. She then read aloud the text of the petition as follows:

"To: The (1) Mayor/President of the South Perth City Council

- 1. Under section 5.28 of the Local Government Act 1995, the electors of the South Perth & Como community whose names, addresses and signatures are set out in the attached list and who comprise (1) 100 electors/5% of the number of electors request that a special meeting of the electors of the district be held.
- 2. The details of the matter to be discussed at the special meeting are:

To discuss matters relating to Development Application 252/2014, 243 Canning Highway, South Perth for a Dan Murphy's liquor store. The following points are submitted for discussion:

- 1. The concerns of electors about the proposed large format liquor development at the Como Hotel site, including but not limited to:
  - 1. Noise
  - 2. Traffic and parking
  - 3. Increase in the negative social effects of alcohol in the community
  - 4. Impacts on adjoining properties

- 2. To provide an opportunity for the Mayor to indicate Council's current position on the matter, given its recent refusal of Amendment 40,
- 3. To consider the following motions:
  - 1. That the people of South Perth oppose the development of a large Dan Murphy's liquor outlet on the Como Hotel Site;
  - 2. That the people of South Perth request that the Council prepare a submission to the JDAP opposing DA 252/2014 consistent with its reasons for refusal of Amendment 40; and
  - 3. That the people of South Perth / Como request that the applicant withdraws their application for the Dan Murphy's to be located at the Como Hotel site & the Development Assessment panel refuse this re-development application."

#### 5.1(c) Open Microphone

The Mayor opened the Public Comment Period for those Electors wishing to speak. She requested that speakers state their name and address.

The following is a 'summary' of comments raised:

#### Michael Lee of 232 Canning Highway South Perth

- Lives opposite the development site.
- Disagrees with speakers.
- Noise exists already (ambulances, fire, police services).
- Traffic will increase anyhow given the plans to redevelop Ernest Johnson Reserve.
- Was former cleaner at the Como Hotel.

#### Lesley Vanstan of 28 Elizabeth Street, South Perth

- Received brochures in letterbox believes the facts are deceiving (eg. size of development and traffic flow):
  - Size of development shown includes current bottle shop.
  - o Traffic studies taken at peak period (eg 6pm on Friday night).
- Those living in Norton Street should be expected to put up with existing noise –
   Como Hotel has been in its location longer than residents.
- Compares traffic at the Como Hotel to the traffic at the Windsor and other liquor sites as similar.
- There are numerous liquor stores all over the place highlighted possible vested interests with speakers.
- Alcohol problems are a minority of the people.

#### John McGrath MLA – Member for South Perth

- Attended as Member for South Perth to hear what residents thought of the development.
- The meeting is an outstanding opportunity for democracy.
- Those who contacted John's office were concerned particularly with traffic movements.
- The City is growing at a rapid pace and the development is located in an already busy thoroughfare to other activity centres.
- Noted the large number of existing liquor outlets in South Perth no shortage of liquor availability already.
- Submitted apologies on behalf of Steve Irons MP, Federal Member for Swan and conveyed on Mr Irons' behalf that he has made a submission to the City of South Perth and opposes the development. The speech notes can be found at **Attachment 9**.

#### Susanne Trenbath of 47 Monk Street, Kensington

• Lives a few streets away from the existing Como Hotel and can hear the noise from patrons.

#### Brian Trenbath of 47 Monk Street, Kensington

• Has had experience with the effect the availability of cheap liquor does to Does not want cheap availability of alcohol to continue

#### Ferdinand Nicoletti of 27 Birdwood Avenue, Como

We need less liquor stores, not more.

#### Andrew Cox of 126 Hensman Street, South Perth

- Drink driving in the vicinity wife's vehicle was "written off" by a drunk driver.
- Not happy with the proposed development.
- Would rather help a local business out.

#### 5.2 Motion

The Mayor invited the nominated representative from the Save Como Action Group, Dr Peter Howat, to read out the Motion from the meeting.

#### **MOTION**

#### That:

- 1. The electors of the South Perth & Como community oppose the development of a large Dan Murphy's liquor outlet on the Como Hotel Site as it will negatively impact the local amenity on the grounds of increased noise, traffic congestion, compromised road safety, insufficient car parking, adequate availability of liquor outlets locally already & ensuring the preservation of heritage & environment;
- 2. The electors of the South Perth & Como community request that the Council prepare a submission to the JDAP opposing DA 252/2014 consistent with its reasons for refusal of Amendment 40; and
- 3. The electors of the South Perth & Como community strongly recommend that the Development Assessment panel refuse the re-development application as it is contrary to orderly and proper planning and the preservation of the amenities of the locality.

Michael Lee of 232 Canning Highway, South Perth spoke AGAINST the motion.

Tina Watson of 25 Norton Street, Como spoke FOR the motion.

## RESPONSES TO QUESTIONS RAISED BY THE <u>SAVE COMO ACTION GROUP</u> Special Electors' Meeting – 14 July 2014

Ι.	What is the City's view regarding the traffic hazards that would be created on South Terrace (and associated streets) as a result of the redevelopment?	The City does not support a change to the median in the form presented. Relocating the transformer to enable the crossing at that point and then widening South Terrace to be two lanes at the repositioned crossing is a possibility.
2.	How does the City view the loss of amenity of adjoining residents through the noise that the redevelopment would create, and given that there would need to be an acoustic wall of at least 3m to manage that?	There is already a significant amount of noise generated from Canning Highway traffic and also from Como Hotel and bottle shop patrons. Additional noise generated if this application is approved, could be managed through a number of mechanisms and would have to comply with the Environmental Protection (Noise) Regulations 1997
3.	Does the City accept that the Dan Murphy's is simply inappropriate as a "big box" in a residential street such as Norton Street?	The Design Advisory Architects Group have noted that the design of the new Dan Murphy's is not consistent with the existing heritage listed hotel. The groups comments have been forwarded to the applicant for their consideration and possible amendment to the design.
4.	How will the City manage the overflow of up to 70-odd cars parking in Norton St? (as the car park will be unable to cope with the traffic counts expected)	The shortfall under the Town Planning Scheme and policy is 5 bays. If approved, there may be overflow parking affecting the adjoining street in peak periods. The applicant has been made aware of this shortfall and there may be possible amendments to the design.
5.	How will the City manage the rat-running of traffic that is likely to occur in Renwick and/or Hensman Streets if MRWA close the median at Norton St?	The applicant has been made aware of the Main Roads requirements and there may be amendments or alterations to the application as a result of this.
6.	Is the City aware that according to Dan Murphy's own numbers, when stores are re-badged (be a former B.W.S or independently branded store for example) customer numbers increase by up to 400%. Will the City consider this major statistic in its recommendation to the JDAP that the site is not suitable to hold the increased traffic / parking needed?	The City will consider the increased patronage as part of the assessment process.



7.	If Norton Street was recently modified to control traffic issues, doesn't this bring back to the table the "real" future risks again to local streets with more traffic wanting to race down or "rat run" to avoid lengthy delays at lights & turning intersections?	Norton Street has traffic calming measures and if required other streets could also be assessed for additional measures to avoid "rat running"
8.	Is the City willing to push for a genuine attempt to maintain and improve the heritage values of the Como Hotel?	The Como Hotel is listed in the City's Municipal Heritage Inventory as Management Category C, which means "retain and conserve if possible". The proposed development is considered to meet those objectives.
9.	If car parking at the Como Hotel is currently at capacity during peak times, then doesn't this reflect that the T.P.S parking shortfall of 62% needs re-considering now by the City? Will the City oppose the car parking plan submitted by A.L.H on the grounds that it will exponentially bring more traffic to the site?	The City has advised the applicant of the shortfall under the Town Planning Scheme and the applicant now has an opportunity to amend the plans or the application to address this matter.
