Minutes of the Annual Electors' Meeting of the City of South Perth Council held in the Council Chamber, Sandgate Street, South Perth, Monday 14 December 2015

I. DECLARATION OF OPENING

6.1 QUESTIONS FROM THE PUBLIC GALLERY

The Presiding Member opened the meeting to questions from the Gallery. The following is a summary of questions and responses received at the meeting:

Roger Atkinson of 5/202 Coode Street, Como

Questions

- a) Where will the City of South Perth be targeting the next wave of urban renewal, high density and mixed use developments (ie. Canning Highway corridor, Canning Bridge Precinct, Curtin to Canning Bridge transport corridor)?
- b) Which localities will be targeted for urban renewal?
- c) How can the electors be informed about where the locations will be?

Response – Vicki Lummer, Director Development and Community Services

You have correctly pinpointed all areas the City is looking at. The next area will most likely be the Canning Bridge Precinct and Council has already completed the Structure Plan and Scheme Amendment for this area – the City is now waiting on approval by the Department of Planning.

With regards to Canning Highway this is a longer term project.

Question

a) With regard to the Station Street Precinct, when are they going to build the station?

Response – Vicki Lummer, Director Development and Community Services

It is not on any state government forward estimates so is impossible to say.

Question

b) Is it deceptive of Council to refer to it as a 'station'?

Response – Vicki Lummer, Director Development and Community Services

No it is not. There will eventually be a station; the freeway has been constructed to allow for the station platforms. The area already has high frequency bus transport.

Question

c) With regards to Canning Highway who does Council believe are the major stakeholders in that area?

Response – Vicki Lummer, Director Development and Community Services

The stakeholders are the Department of Housing, Department of Transport, Main Roads, Land Owners and Ratepayers.

Question

d) What weighting would you allocate as a % to each stakeholder (ie. who is more influential?)

Response – Vicki Lummer, Director Development and Community Services

Each group has different interests. We do not weigh each against the other but take into consideration all feedback from all stakeholders when community consultation is sought.

Question

a) Will the local residents hold any veto power over any developments?

Response – Vicki Lummer, Director Development and Community Services

Development decisions are made by Council, not the Community so no they could not veto any decision of Council. Community Consultation is sought before Council decisions are made and before any decision is forwarded to the Minister for approval.

Question

a) Does the parcel of land within the Department of Agriculture belong to the City of South Perth or the State?

Response – Councillor Glenn Cridland, Deputy Mayor and Presiding Member

The City is not aware of any interests in the Department of Agriculture but will endeavour to investigate.




