# 10.1.1 Department of Local Government, Sport and Cultural Industries - Community Sport and Recreation Facilities Fund Small Grants Program 2023/24 - Application and City Assessment

This Item was the subject of one Deputation.

Each year the Department of Local Government, Sport and Cultural Industries (DLGSC) calls for applications for its Community Sport and Recreation Facilities Fund (CSRFF). They invite eligible community groups and local governments to apply for funding to assist with sport and recreation infrastructure projects.

CSRFF applications must initially be presented to the relevant local government to request in-principle support of the project, including the financial contribution requested by the applicant under the CSRFF program.

Two external applications are presented for the current round of the CSRFF for 2023/24:

- 1. Manning Bowling Club Bowling Green Synthetic Conversion Project
- 2. Como Bowling Club Bowling Green Synthetic Conversion and Plinth Replacement Project
