  - (b) if satisfied, to agree to any minor amendments to the proposed employment contract that are consistent with the advertised remuneration and benefits; and
- 7. If the proposed employment contract with any minor amendments is accepted by the preferred candidate, Council authorises the Mayor to:
  - (a) affix the City's common seal to the final version of the proposed employment contract; and
  - (b) sign the contract on behalf of the City.
