## **Special Electors' Meeting - Minutes**

Minutes of the Special Electors' Meeting held in City of South Perth Council Chamber, Cnr Sandgate Street and South Terrace, South Perth at 6pm on Monday 18 December 2017.

#### 1. DECLARATION OF OPENING

#### 1.1 Welcome introduction

The Presiding Member opened the meeting at 6.04pm and welcomed everyone in attendance. He then acknowledged we are meeting on the lands of the Noongar/Bibbulmun people and that we honour them as the traditional custodians of this land.

#### 1.2 Presiding Member's statement

The Presiding Member outlined the following points in relation to proceedings of the meeting:

- The Presiding Member reported that the meeting is being audio recorded in accordance with Council Policy P673 'Audio Recording of Council Meetings' and Clause 6.15 of the Standing Orders Local Law 'Recording of Proceedings'.
- He then gave his permission for the Administration to record proceedings of the Council meeting and requested that all electronic devices be turned off or on to silent.
- To vote on any Motion raised this evening you must be an elector of the district. The registration (attendance) list is to be completed in the foyer.
- This meeting is not a Council meeting but a meeting requested by the Electors.
  Councillors are not obliged to attend Special Electors' Meetings. Those present
  here this evening have chosen to do so to listen to the comments made by the
  residents and ratepayers of the City.
- Councillors will not respond to any questions. Any Councillor wishing to speak does so as an Elector.
- The meeting will commence with the reading of the Petition received on 1 December 2017 from Mr Mark Goodwin.
- The City's Director Development and Community Services, Ms Vicki Lummer, will then provide the details of the Development Application 367/2017, 264 Canning Highway, South Perth (Farmer Jacks).
- Steve Russell of Hobbs Avenue, Como will be invited to make a statement on behalf of the Petitioner, Mr Mark Goodwin and the signatories.
- Consultant Mr Steve Fairfoul of Rowe Group will be invited to make a presentation on behalf of the signatories.



- Those who submitted questions prior to the meeting will be invited to the microphone. Each speaker will have 10 minutes to address the meeting.
- I will then invite Mr Mark Goodwin, as Petitioner, to read aloud the proposed Motions as listed in the petition; which will be read as one motion together.
- I will call for a Seconder for the motion.
- Speakers FOR and Speakers AGAINST the Motion will then have the opportunity to speak.
- I will then put the Motion to a vote and ask that those Electors present raise their hands FOR the Motion, followed by a raising of hands AGAINST the Motion please note again that only Electors of the district are entitled to vote.
- Any Motion passed this evening will be considered by Council at a future Council Meeting.

#### 3. PETITION

The Presiding Member stated that the meeting had been called in response to a petition received on 1 December 2017 together with 127 signatures. He then read aloud the text of the petition as follows:

'To the Mayor of City of South Perth

- 1. Under section 5.28 of the Local Government Act 1995, the electors of Como, Kensington and South Perth Communities whose names, addresses and signatures are set out in the attached list and who comprise (1) 100 electors/5% of the number of electors request that a special meeting of the electors of the district be held.
- 2. The details of the matter to be discussed at the special meeting are The purpose of the meeting is to discuss matters relating to Development Application 367/2017, 264 Canning Highway South Perth. The following points are submitted for discussion:
  - 1. The concerns of electors about the proposed Farmer Jacks development on Canning Highway Como, including but not limited to:
    - a) Noise
    - b) Traffic & vehicle safety
    - c) Parking
    - d) Impacts on adjoining properties and residents in the surrounding area.
  - 2. To provide an opportunity for the Mayor to indicate Council's current position on the matters.
  - 3. To consider the following motions:
    - a) That the people of South Perth & Como oppose the development of this Supermarket development at 264 Canning Highway, Como;
    - b) b. That the people of South Perth & Como request the City prepare a submission to the JDAP opposing DA367/2017;
    - c) That the people of South Perth & Como request the City officers support the objections from the community and detail this in their Responsible Authority Report to the JDAP;
    - d) The electors of the South Perth & Como community strongly recommend that the Development Assessment panel refuse the development application as it is contrary to orderly and proper planning and the preservation of the amenities of the locality.'



## 4. PRESENTATION FROM THE DIRECTOR DEVELOPMENT AND COMMUNITY SERVICES

The Presiding Member invited the Director Development and Community Services, Ms Vicki Lummer to the microphone.

Ms Lummer provided a power point presentation giving an overview of Development Application 367/2017, 264 Canning Highway, South Perth (Farmer Jacks) which can be found in the **Appendix** of these Minutes.

#### 5. PETITIONER'S STATEMENT

The Presiding Member invited Mr Stephen Russell of Hobbs Avenue to speak on behalf of the petitioner Mr Mark Goodwin and the signatories.

The Presiding Member then invited Sean Fairfoul to the microphone to speak on behalf of the signatories.

# **Proposed Development**

The proposal incorporates the following:

- A new 2-storey commercial building with basement car parking.
- 3 Shop tenancies A supermarket\* and 2 smaller retail tenancies.
- 59 permanent car bays, located in the basement.
- 41 temporary car bays at ground level, located in land reserved for future highway widening.
- Car park access is from Canning Highway only.
- Supermarket delivery vehicles enter from Hobbs Avenue and exit onto Canning Highway. (Easement on Title)

\* The applicant has advised that the supermarket tenancy is intended to operate as a Farmer Jack's supermarket.


